A motion was made by Fleming, seconded by Graalman, and unanimously carried to appoint Ed Reed to the Baggs Solid Waste Disposal District for a four year term beginning September 17, 1996 and ending September 17, 2000.

CARBON COUNTY COUNCIL OF GOVERNMENTS

A motion was made by Fleming, seconded by Graalman, and unanimously carried to adopt the following resolution:

R E S O L U T I O N 1 9 9 6 - 1 0

RESOLUTION OF THE BOARD OF COMMISSIONERS OF CARBON COUNTY,
WYOMING AUTHORIZING THE PARTICIPATION OF CARBON COUNTY
GOVERNMENT WITHIN THE CARBON COUNTY COUNCIL OF GOVERNMENTS
(CCCOG).

WHEREAS, the Board of Commissioners of Carbon County, Wyoming desires to participate as a voting member of the Carbon County Council of Governments; and

WHEREAS, the purpose of the Council of Governments is to facilitate communication and cooperation amongst the member communities; and

WHEREAS, the Council of Governments membership is made up of the municipalities and elected officials within Carbon County; and

WHEREAS, it appears that membership in the Council of Governments would be in the best interest of the county; and, all members will be provided one vote for one entity and each entity is to appoint their voting member and designee, officials are encouraged to attend, participate in the dialogue and be part of the cooperative community,

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Carbon County, Wyoming that Carbon County Government is authorized to assist in the organization, promotion and establishment of the CCCOG and to participate therein for so long as it is in the best interest of the county.
