Board met pursuant to adjournment of yestarday, Sept. 4th, Roll call showing present Commissioners D. C. Jones, W. M. McKay, Evan Veitch, Chariman and Dee J. Wren Clerk.

Proceedings were had as follows to wit)-

The Board proceed to make the levy upon the requisite taxes upon the assesed and taxable property within the County of Carbon , State of Wyoming for the year of 1911, A. D. for the State and School Revenue, as provided by law.

The Statement from the State Auditor was presented, same being recieved by the Board. and ordered filed.

The County Assesor submitted the certified statement from the State Auditor of the State of Wyoming, showing the assesment of said Carbon County, as made by the State Board of Equalization for the year A. D.1911 and the properties of corporations, Railroads, Car and Telegraph lines as hereinafter set forth, and the County Clerk is hereby instructed to add the amounts returned by the State Auditor, to the assesments of said Carbon County for the year of 1911, same being as follows:-

At a meeting of the State Board of Equalization held the 15th day of Aug. A. D.1911, the rate of levy upon each Dollar of valuation for State Revenue for the year of 1911, was fixed at 3 and 2 tenths mills and the Board were thereby directed to make this levy as provided by law.

The Amount of State tax charged to Carbon County for the year of 1911 is \$50,772.31.

It is hereby ordered by the Board of County Commissioners that the following amounts be levied and assesed upon each and every Dollar of the taxable, real and personal property in said County and State of Wyoming and upon the assesed valuation thereof as is shown by the assesment roll of said Carbon County, State of Wyoming for the year of 1911 A D. including the valuation of property of Rail road, car and telegraph companies as assesed to the by the State Board of Equalization.
