Board adjourned to 2 o'clock P. M.



Proceedings were had as follows to-wit:-

sherrif D. B. Campbell, same being shipped during the months of Nov. and Oct. was recieved and ordered riled and published.

Refund from Dr. Sam F. Price for cash advanced for pauper, Carey, in amount of \$1.00, same was ordered turned back to the County Treasurer and credited the Poor and Pauper Fund.

Owing to numerous petitions asking that the Board grant a thirty day extention of time in which to pay taxes, the Board hereby orders embodied in the proceedings of this regular meeting. That having been fully advised of thier descretion in the matter, wherein Section 2406 of the Compiled Statutes of Wyoming, for 1910, states in substance that all taxes must be paid not later than the 31st day of December in each year, and all such taxes not paid by such time become delinquent and penalty and interest charged as provided by law, the Board sees no way in which to grant this extention of time except upon the direct violation of the law, and therefore have no descretion in the matter.
