


WHEREAS said property was bid in by Carbon County, Wyoming at said sale and

WHEREAS, the time for redemption of said lands has expired, whereby the title to said lands passed into Carbon County, and

WHEREAS, Adolph Englehart has offered to pay to Carbon County, to the amount of said lots 1 and 2 block 22 was sold for together with all interests, costs, taxes assessed against said lands due and remaining unpaid to date and other expenses incurred to date amounting to a total of \$194.43

NOW THEREFORE, be it resolved by the Board of County Commissioners, that the said lands be sold to Adolph Englehart for the said sum of \$194.43 and the Chairman of this Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said property to the said Adolph Englehart.

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS FEB. 9th, 1912.

Board met pursuant to adjournment of Feb. 8th, Roll call showing present Commissioners D. C. Jones, Evan Veitch, Wm. A. McKay chairman and Dee J. Wren, Clerk.

Proceedings were had to - wit :-

Rebate of 1 & 1/2 Mills upon Road and Bridge Levy.

Commissioner Veitch offered the following resolution:-

Be it resolved by the Board of County Commissioners of Carbon County, Wyoming, that there be refunded and rebated upon the levy of two mills made for the support and keep of roads for the year 1911 as evidenced in the proceedings of said County Commissioners of Date Sept. 4th A. D. 1911 at page 54 of Commissioners Record 5 of said County, the sum of one and one half mills upon the dollar valuation.

That said rebate and refund be paid as follows; that upon all taxes that have been heretofore paid, the County Clerk is hereby instructed and authorized to make a certificate of rebate, payable to the order of payee of said taxes heretofore paid and to be paid to the said payee of said taxes in the following manner to-wit; same may be accepted at face value by the County Treasurer in payment of 1912 taxes or any debt or debts due said Carbon County, or, upon receipt of tax receipt showing amount of taxes paid, the County Treasurer is authorized and instructed to pay refund warrant to said amount of one and one half mills upon the dollar valuation, and charge same to the road and bridge fund upon his books.

In cases where 1911 taxes are still due and collectible upon the books of the County Treasurer, the County Clerk is hereby instructed to transmit this resolution to the County Treasurer and the County Treasurer is hereby authorized and instructed to rebate from the County General tax the amount due and collectible for road and bridge purposes, the sum or sums produced by applying to the valuation and give a receipt in full for taxes of 1911, noting upon said receipt that said rebate of one and one half mills was duly authorized by the Board of County Commissioners of said County.

Commissioner Veitch moved that the resolution above be adopted, same was seconded by Commissioner McKay.
