Proceedings were had as follows, to-wit:-

The Board proceeded to make the levy for the requisite taxes upon the assessed and taxable property within the County of Carbon and State of Wyoming for the State and School Revenue, for the year 1913 A. D. as is provided by law.

The Statement from the State Auditor was presented, read and ordered filed.

The County Assessor submitted the certified statement from the State Auditor of the State of Wyoming, showing the assessment of said Carbon County, as made by the State Board of Equalization for the year of A. D. 1913 and the properties of corporations Railroads, Car and Telegraph Lines as hereinafter set forth, and the County Clerk is hereby instructed to add the amounts returned by the State Auditor, to the assessments of said Carbon County for the year of 1913, same being as follows:-

At the meeting of the State Board of Equalization the rate of levy upon each Dollar of valuation for State Revenue for the year of 1913, was fixed at 3 mills and the Board were thereby directed to make this levy as provided by law.

The amount of State Tax charged to Carbon County for the year of 1913 is \$46,691.16.

It is hereby ordered by the Board of County Commissioners that the following amounts be levied and assessed upon each and every dollar of the taxable, real and personal property in said County and State of Wyoming and upon the assessed valuation thereof as is shown by the assessment roll of said Carbon County, State of Wyoming for the year of 1913, including the valuation of property of Railroad, Car and Telegraph Companies as assessed to them to them by the State Board of Equalization.


