Board met this 4th. day of November A. D. 1913, in regular session as is by law required. Roll call showing present Commissioners Robt. A. Day, D. C. Jones, Wm. A. Mc Kay, Chairman, and L. B. Magor, Clerk.

Proceedings were had as follows, to-wit:-

Mr. A. M. Stattzell, appeared before the Board asking for a rebate of taxes of Mrs. S. M. Miller. Whereupon the Board asked that Mrs. Miller file an affidavit for rebate stating her reasons and that they would act on the same at this meeting.

Mr. Ewd. Cheesbrough appeared before the Board in the matter of his land valuations and same was referred to Assessor Chas. B. Boyce, to classify his land and submit his returns to the Board at their next regular meeting.

The matter relative to the adoption of a road as the State Highway through Carbon County, Wyoming, was discussed by the Board to determine the best and cheapest route to adopt and after due consideration the Board drew up the following official notice and ordered a copy of the same forwarded to the State Engineer to be signed by the Chairman of the Board and attested by the Clerk.

THE official Notice as drawn up is as follows, to-wit:-

Under and by virtue of Chapter 44, of Session Laws for 1911, pertaining to Public High-Ways within this state, we, the Board of County Commissioners of the County of Carbon in the State of Wyoming, hereby give official notice, that the Board of County Commissioners of the said County of Carbon, have agreed to adopt and have adopted the route now surveyed from Laramie to Rawlins, by way of Bosler, Rock River and Medicine Bow, as a county road for the purposes set forth in said Chapter 44 above referred to.

We, as such Board of County Commissioners of said County of Carbon, hereby request that you designate said high-way herein referred to as the State High-way through this county, as provided for by law.

That at a joint conference heretofore held between the County Commissioners of this County and the County Commissioners of Albany County, Wyoming, both Boards herein agreed and adopted the above route as a county road and high-way through the respective counties herein named. You will undoubtedly receive official notice from the County Commissioners of Albany County. within the next few days.

We trust you will take the necessary steps to carry into effect the high-way as above designated and adopted by the Board of County Commissioners of the respective Counties herein named, as required by law. We will at any time give you any information herein that you may require.

It was moved by Commissioner Day and seconded by Commissioner Jones that the above procedure and notice be accepted as drawn and same to be inserted in the minutes.

Roll call of vote, Commissioner Day, Commissioner Jones and Commissioner Mc Kay voting aye.

A communication was received by the Board from State Chief Counsel of the Lincoln Highway Association, same was read and ordered filed.

ASSIGNMENT OF TITLE.

At a Tax Sale of Delinquent Taxes in July, 1913 property ##### being part of Lot 20 and all of Lot 21, in Block 88 in the Town of Grand Encampment, Wyoming and Lots 13 and 14 in Block 89 in the Town of Grand Encampment, Carbon County, Wyoming; there being no other bidders, was bid in by the County for the amount of such delinquent taxes.

A bid was received from Ed. L. Woods of Grand Encampment, Wyoming, of \$14.25 for part of Lots 20 and all of Lot 21, in Block 88, and \$9.25 for Lots 13, and 14 in Block 89, in Grand Encampment, Wyoming, petitioning the Board of County Commissioners of Carbon County for permission to pay the said amount and take an assignment from the County in proper form of its interests in the property under the tax sale above mentioned, the above amounts being sufficient to cover all costs, principal and interest and also the 1913 taxes.

It was moved by Commissioner Day and seconded by Commissioner Jones that same be accepted and proper assignments made to Ed. L. Wood. Motion carried.
