Board met at 10 o'clock A. M. this 2nd. day of December A. D. 1914. pursuant to adjournment of December 1st. 1914. Roll call showing present, Commissioners D. C. Jones, Robt. A. Day, Wm. A. Mc Kay, Chairman and L. B. Magor, Clerk.

Proceedings were had as follows, to-wit:-

Mr. Dolan appeard before the Board and presented a survey os a road running from the County Road between Dixon and Savery Wyoming south across Snake River to the Colorado Line This road having been built by tax-payers of that section and desirous of having this become a county road presented deeds to the following described land which the road crosses, to-wit:-

A strip of land twenty-five feet wide on each side of a line beginning at a point South 5° 56' West 831.35 feet South 1° 15' 30" 1792 feet from quarter section Corner between Sections 11 and 12, Township 12, North of Range 90, West of the Sixth P. M. and running South 1° 15' 30" East 1332 feet.

A strip of land fifty feet wide to be used for road or public highway purposes, being twenty-five feet wide on each side of a certain line beginning at a point S 5° 56' W. 831.35 ft. from quarter Section Corner between Sections 11 and 12, Tp. 12. North of Range 90, W. of the 6th. P. M. ; and running thence S 1° 15', 30" E. 1793 ft. to the South line of said Section 11.
