

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS . MARCH, 3rd. 1914.

Board met in regular session this 3rd. day of March, A. D. 1914, as is by law required. Roll call showing present. Commissioners Robt. A. Day, Wm. A/Mc Kay, Chairman and L. B. Major, Clerk. Commissioner D. C. Jones. Absent.

Proceedings were had as follows, to-wit:-

The minutes of the previous meeting were read and approved.

Whereas it appears that at a meeting of the Board held on January 6th. A. D. 1914, regarding the establishing of a county road to the proposed fish hatchery and that at that meeting a part of the description of said road was omitted, whereupon it was moved by Commissioner Day and seconded by Commissioner Mc Kay that the minutes of that date be corrected to read with the following road description added and that the Clerk is hereby instructed to advertise this road. Motion carried.

## ROAD DESCRIPTION.

That certain strip of land 60 feet in width lying in Section 36 Township 18 North Range 84 West in Carbon County, Wyoming and along the west line of the Saratoga and Encampment right of way and described as follows:- Beginning at a point 60 feet South 10° 50' West of where said Railroad right of way boundary line crosses the north boundary line of said Section 36, thence South 17° West 145 feet along said Railroad right of way west line thence South 20° 5' West 175 feet, thence South 23° 20' West 2387 feet, thence South 20° 45' West 230 feet to a point in the centre of the County road from Saratoga to Pass Creek, thence South 58° West along said road to a point from which a line drawn north will be parallel with and 60. feet from the line above described. Thence North 20° 45' East 238 feet, thence North 23° 20' East 2387 feet, thence North 20° 45' East 175 feet, thence North 17° East 144 feet to a point on the south boundary line of the proposed county road along the north line of said section 36, thence East 60 feet to the place of beginning being four acres more or less in said Section 36.

Owing to the resignation of Mr. M.E. Pickett, Deputy Sheriff of Carbon County, Wyo. Sheriff Rubie Rivera submitted his appointment of Mr. F.D. Denison to that office for the approval of the Board. It was moved by Commissioner Day and seconded by Commissioner Mc Kay that the appointment as submitted to the Board be confirmed.
