Board met at 2 o'clock P. M. May, 7th. 1914 pursuant to adjournment of morning session, Roll call showing all members present.

Proceedings were had as follows, to-wit:-

SALE OF PROPERTY.

BE IT RESOLVED, That whereas Lots 1 to 24 in Block 35 in the town of Grand Encampment, Carbon County, Wyoming were sold for taxes on June, 30th. 1911 for 1910 taxes, and

WHEREAS, Said property bid in by Carbon County at such sale, and

WHEREAS, The time for redemption of said lands has expired, whereby title to said lands passed into Carbon County, and

WHEREAS, George Kuntzman has offered to pay to Carbon County to the amount of \$55.00

for said lots which amount will amply re-imburse Carbon County for taxes, penalties interest and expenses incurred to date, ##

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners that the said lands be sold to George Kuntzman for the sum of \$55.00 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said George Kuntzman.

BE IT RESOLVED, That whereas the Southeast Quarter of Section One (1) and all of Section Three (3) in Township Eighteen (18) North, Range Eighty-One (81), were sold for taxes July 7th. 1905 for 1904 taxes, and

WHEREAS, Said Property was bid in by Carbon County at such sale, and

WHEREAS, The time for redemption had expired, whereby title to said lands passed into Carbon County, and

WHEREAS, The Basin Land and Live Stock Company, a corporation, did on March, 7th. 1914, pay to Carbon County \$28.82 for the redemption of said above described lands and as the time of redemption had passed and the same subject to deed.

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners that the said lands be deeded to The Basin Land and Live Stock Company, a corporation, and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of Conveyance to the Basin Land and Live Stock Company a corporation, upon the return and cancellation of the redemption certificate issued to the above mentioned company of March, 7th. 1914.

The bid of C. H. Ashley was presented to the Board on Lots 7, 8, 9, and 10 in Block 87 in the Town of Grand Encampment, Wyoming, for commissioners deed in the amount of \$25.00. The Board upon considering the above bid found that the amount to be insufficient to cover the taxes, costs and etc. on said property and therefore rejected said bid.

#### ASSIGNMENT OF TITLE.

At a Tax Sale of Delinquent Taxes in June, 24th. 1912 being Aetna Mining Company's property, Carbon County, Wyoming; there being no other bidders, was bid in by the County for the amount of such delinquent taxes.

A bid was received from Julius Thielman and E. F. Hanf of Merrill, Wisconsin, for \$135.30, petitioning the Board of County Commissioners of Carbon County, for permission to pay the said amount and take an assignment from the County in proper form of its interests in the property under the tax sale above mentioned, the above amounts being sufficient to cover all costs, principal and interest and also the 1913 taxes.

Moved by Commissioner Jones and seconded by Commissioner Day that the Board adjourn to meet in regular session of June, 2nd. 1914.
