Board met at 10 o'clock A. M. this 9th. day of July A. D. 1914. pursuant to adjournment of July, 8th. 1914. Roll call showing present, Commissioners D. C. Jones Robt, A. Day. Wm. A. Mc Kay, Chairman and L. B. Magor, Clerk.

Proceedings were had as follows, to-wit:-

Mr. Chas. E. Blydenburgh appeared before the Board relative to the tax of Mr. Warren stating that this land was Stone Land and asked that a rebate of valuation be made and the Board instructed Mr. Blydenburgh to file an affidavit setting out the facts when some action would be taken.

ASSIGNMENT OF TITLE.

Bid was received from Mr. Geo. e. ROAD DISTRICTS.

Owing to the necessary changes to be made in the two Road Districts in Carbon County, the following districts are hereby established, in complianced with Section 2547. Session Laws of Wyoming 1913, regarding the dividing of the County into Road Districts:-

ROAD DISTRICT NO. 1.

Road District No. 1, shall comprise all that part of Carbon County lying west of a line described as follows:-

Beginning at the intersection of the line between Ranges 85 and 86 and the Colorado line; thence north on said line to the N. E. Corner of Township 13, N. R. 86 W. ; there
