R. 89 West, thence South 1320 ft. at Sta. 1320 the corner common to Secs. 7, 8, 17, and 18, bears east 30 feet, thence South 467 feet; thence east 30 ft. to the line between Sections 17 and 18; thence south along said section line 2853 ft; thence S. 59 Deg. 10' E. 530 feet; thence south 31 deg. 14' W. 321 ft. to a point 30 feet east of said section line; thence south on a line 30 ft. east of said section line; thence south on a line to the Colorado and Wyoming State Line.

Said road to be 60 feet wide lying 30 feet on each side of the above described line
