The minutes of the last meeting were read and approved.

The matter which has been underway with the Union Pacific Railroad Company as to the establishment of a public road crossing west of Rawlins, where the crossing with gates is at present and on communication from the Union Pacific Railroad Land Commissioner stating that the Railroad Company is agreeable to making the private road crossing 950' West of Mile Post 694 a public crossing with the understanding that the Commissioners of Carbon County agrees to waive all rights to a public crossing on the Section line between Sections 22 and 23 Twp 21, N. R. 88 W. The present private crossing being in a most desirable locations.

On motion by Commissioner Day and seconded by Commissioner Christensen, the Board agrees to waive all rights to a crossing between Sections 22 and 23 upon the Union Pacific Railroad Co. establishing a public crossing where the present private crossing is located 950' west of the Mile Post No. 694 and a copy of the Board action be forwarded to the Union Pacific Railroad Land Commissioner.


WHEREAS, The time for redemption has expired whereby title to said lands passed into Carbon County, and
