Read A Petition was presented to the Board, signed by a large number of Resident Tax-Payers of the Snake River Valley, petitioning the Board to advertise for bids for for construction of a graded road from Baggs to the Muddy Bridge Crossing. The same was read and ordered filed.

Assessor Chas. B. Boyce submitted the appointment of Harry W. Hansen, as Deputy Assessor of Carbon County, Wyoming, for a term of two years. It was regularly moved and seconded that the above appointment be and the same is hereby approved.

In the matter of the advertised call for bids in November, 1916, for the sale of a portion of the County Poor Farm at Dixon, Wyoming, was discussed by the Board and the bid submitted by John Terrill to purchase said parcel of land for the sum of \$50. per acre, being the only bid for said land, it was regularly moved and seconded that

the bid of Mr. John Terrill be accepted and that ^{at} the request of Mr. John Terrill that the deed be made to Mr. Charles Terrill. Motion carried.

The Board after considering all bids for the ^{of the inmates/} care and leasing of the County Poor Farm for the next two years, and Mr. and Mrs. Peter Johnson ^{submitting/} request that the \$25.00 for wages for care of Poor Farm be omitted from their bid, and it appearing to the Board that the bid of E. J. Colley, that 50¢ per day for the boarding and caring of each inmate and his offer of \$250.00 per year for rental of the Poor Farm, being the lowest and best bid, it was moved by Commissioner Day and seconded by Commissioner Mc Kay that Mr. E. J. Colley be awarded the contract upon his signing an agreement submitted by the County Commissioners, he also to furnish Bond to be approved by the Board. Roll Call of Vote. Commissioners Day, Rasmussen and Mc Kay all voting aye.

There being no other business coming before the Board it was regularly moved and seconded that the meeting adjourn to meet again in regular session on March 6th. A. D. 1917. Motion carried.
