REPORTS.

Reports of Justices of the Peace J. Waeckerlin, P. P. Murphy and Edw. Mc Atee, and the report of County Treasurer E. M. Tierney were read and ordered filed.

An application for deposit of County Funds was presented by the Stockgrowers Bank of Dixon, Wyoming. It was moved by Commissioner Christensen and seconded by Commissioner Day that the above named bank be accepted as a County Depository at the usual rate of interest. Motion carried.

A petition was received signed by a number of Stockmen as follows, to-wit:-

"We the undersigned taxpayers of Carbon County, respectively request your Honorable Board to set aside a trail for Live Stock, the lands described in the Blue Print here-with attached and made a part of this petition. We find it impossible to reach the Medicine Bow Forest Reserve with sheep unless such trail is granted.

Dated at Walcott, Wyoming May. 13. 1916."

The above matter was referred to Commissioner Day for his investigation, he to report at the next regular meeting.

A petition was received from the east end of the County signed by a large number of residents and tax-payers of that section to change the road east of Medicine Bow Wyoming, as follows:-

Starting where the Lincoln Highway at present crosses the Union Pacific Tracks east of Medicine Bow. In place of crossing the track and following the North line of Sections 15 and 16, to follow the north line of Union Pacific Right-of-way to where its intersects section 8; thence north on east line of section 8 to the Old Union Pacific Grade; thence use grade to town.

No definite action was taken on the above and the petition was laid over until the next regular meeting.
