Proceedings were had as follows, to-wit:-

ASSIGNMENT OF TITLE.

At a Tax Sale of Delinquent Taxes held June, 30th. 1917, Lots 14 and 15 in Block 11 in the town of Grand Encampment, was sold for the 1916 taxes to Carbon County, Wyoming. A bid was received from Mary A. Bohn for the assignment of the County's Title to the above property, and the check enclosed for \$10.59, being sufficient to pay all costs, taxes, penalties and interest on the above property, it was moved by Commissioner Rasmussen and seconded by Commissioner Mc Kay that the offer of Mary A. Bohn be accepted and assignment made. Motion carried.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said Horace B. Quivey for the sum of \$35.00 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said Horace B. Quivey.
