

and secure, in a legal manner, such right-of-way for said road as may be necessary and required by the alignment and grade, this width, wherever possible, to be not less than 40 feet on each side of the proposed center line of construction and if less than 40 feet on either side of said center line, in no case shall it be less than that which will be necessary for the proper slopes of banks in either cuts or fills.


