Proceedings were had as follows, to-wit:-

ELECTION DISTRICTS.

In compliance with Section 146 of the Compiled Statutes of Wyoming, 1910, the Board established Election Districts as follows: also Election Precincts in the several Districts:- towit:-

DISTRICT NO. 1. RAWLINS.

All that territory embraced within the following boundaries shall be known as Election District No. 1.

Beginning at the Northeast corner of Township 24 N. R. 86 W; thence west along the township line between townships 24 and 25 to the northwest corner of Township 24 N. R. 89 W; thence south along the west boundary line of Carbon County to the southwest corner of township 20 N. R. 89 W.; thence east along the township line between townships 19 and 20 to the northeast corner of township 19 N. R. 89 W.; thence south on the Range line between Ranges 88 and 89 W. to the southeast corner of township 16 N. R. 89 W. thence east to the southeast corner of township 16 N. R. 88 W.; thence north on Range line between Ranges 87 and 88 to the northwest corner of township 17 N. R. 87 W.; thence east along the township line between townships 17 and 18 to the southeast corner of township 18 E. R. 86 W.; thence north to the northwest corner of township 18 N. R. 85W. thence east on township line to the southeast corner of township 19 N. R. 85W. thence north on Range line to the southeast corner of township 20 N. R. 85W.; thence west on township line to the southeast corner of Township 20 N. R. 86 W.; thence north on the range line between Ranges 85 and 86 to the northeast corner of township 24 N. R. 86 W. the place of beginning.

DISTRICT NO. 2. FERRIS.

All that territory embraced within the following boundaries shall be known as Election District No. 2.

Beginning at the southwest corner of Township 25 N. R. 89 W; thence east on a line between township 24 and 25 to the North Platte River; thence northwesterly along the North Platte River to the line between sections 18 and 19 Twp. 27 N. R. 84 W; thence west along the line between sections 18 and 19 Twp. 27 N. R. 84 W. to the line between Ranges 84 and 85; thence north along the line between Ranges 84 and 85 to the north line of Carbon County; thence west along the line between Carbon and Natrona Counties to the line between Carbon and Fremont Counties; thence south along the west line of Carbon County to the place of beginning.

DISTRICT NO. 3. FORT STEELE.

All that territory embraced within the following boundaries shall be known as Fort Steele Election District No. 3.

Beginning at the Southeast corner of Township 20 on the line between Ranges 84 and 85; thence North on said line between Ranges 84 and 85 to the line between townships 24 and 25, thence west along said line between townships 24 and 25 to the line between Ranges 85 and 86; thence south along said line between Ranges 85 and 86 to the line between Townships 19 and 20; thence east along said line between townships 19 and 20 to the place of beginning.

## DISTRICT NO. 4. LEO.

All that territory embraced within the following boundaries shall be known as Election District No. 4.

Beginning at the southeast quarter of Township 24 N. R. 80 W.; thence north on Range line Between Ranges 79 and 80 to the northeast quarter of Twp. 25, N. R. 80 W.; thence west on Township line between Twps. 25 and 26 to the northwest corner of Twp. 25. N. R. 80 W. ; thence north along the line between Ranges 80 and 81 to the north line of Carbon County; thence west along the north line of Carbon County to the line between Ranges 84 and 85 W.<sup>thence south</sup> to the line between sections 18 and 19 Twp. 27. N. R. 84W; thence east along the line between sections 18 and 19 Twp. 27. N. R. 84 W. to the North Platte River; thence southeasterly along the North Platte River to the line between townships 24 and 25 ; thence east along the line between townships 24 and 25 to the Northwest corner of Twp. 24. N. R. 83 W. thence south to the southwest corner of Twp. 24 N. R. 83 W.; thence east along the line between townships 23 and 24 to the place of beginning.

## DISTRICT NO. 5. MEDICINE BOW.

All that territory embraced within the following boundaries shall be known as Medicine Bow Election District No. 5.

Beginning at the northeast corner of Carbon County,; thence west along the North boundary line of Carbon County to the northeast corner of Township 28 N. R. 81 W. ~~if~~ thence south on the Range line between Ranges 80 and 81 to the southwest corner of Twp. 26, N. R. 80W.; thence east on the line between townships 25 and 26 to the southeast corner of Twp. 26. N. R. 80 W.; thence south alnng the Range line between Ranges 79 and 80 to the southwest corner of Twp. 22 N. R. 79 W. ; thence east on the line between Townships 21 and 22 to the east boundary line of Carbon County; thence north along the east boundary line of Carbon County, Wyoming, to the place of beginning.

## DISTRICT NO. 6. HANNA.

All that territory embraced within Townships 21, 22 and 23 in Range 81, 82 and 83 W. and also all of Townships 22 and 23 in Range 80 W. shall be known as Hanna Election District No. 6.

## DISTRICT NO. 7. ELK MOUNTAIN.

All that territory embraced within the following boundaries shall be known as Elk Mountain Election District No. 7.

Beginning at the boundary line between Carbon and Albany Counties and on the line between townships 19 and 20, thence north on <sup>eastern/</sup> said/boundary line of Carbon County to the line between townships 21 and 22; thence west on said line between townships 21 and 22 to the line between Ranges 80 and 81 W.; thence south on said line between Ranges 80 and 81 to the line between Townships 19 and 20; thence east on said line between townships 19 and 20 to the place of beginning.

## DISTRICT NO. 8. ROCK DALE.

All that territory embraced within the following boundaries shall be known as Rockdale Election District No. 8.

Beginning on the boundary line between Carbon and Albany Counties and on the line between townships 16 and 17; thence north on said County line to the line between townships 19 and 20; thence west on said line between townships 19 and 20 to the line between Ranges 80 and 81; thence south on said line between Ranges 80 and 81 to the line between townships 18 and 19; thence west on said line between townships 18 and 19 to the Range line between Ranges 81 and 82; thence south on said line between Ranges 81 and 82 to the line between townships 17 and 18; thence east on said township line to the line

between Ranges 79 and 80; thence south on said line to a point between townships 16 and 17.; thence east on said line between townships 16 and 17 to the place of beginning.

DISTRICT NO. 9. GREEN.

All that territory embraced within the following boundaries shall be known as Green Election District No. 9.

Beginning at the southeast corner of Township 19, N. R. 81 W.; thence north on the line between Ranges 80 and 81 to the line between townships 20 and 21; thence west along the line between townships 20 and 21 to the line between Ranges 83 and 84; thence south on said line between Ranges 83 and 84 to the line between townships 18 and 19; thence east on said line between townships 18 and 19 to the line between Ranges 80 and 81 the place of beginning.

DISTRICT NO. 10. SARATOGA.

All that territory embraced within the following boundaries shall be known as Saratoga Election District No. 10.

Beginning at the southeast corner of Sec. 1. Twp. 16. N. R. 83 W.; thence north on line between Ranges 82 and 83 to the line between Townships 17 and 18; thence east on said line between townships 17 and 18 to the line ~~xxxxxx~~ between Ranges 81 and 82; thence north along said line between Ranges 81 and 82 to the line between Townships 18 and 19. & thence west along said line between townships 18 and 19 to the line between Ranges 85 and 86/ ~~Ranges 85 and 86/~~ to the line between ~~xxxxxx~~ townships 17 and 18; thence west on said line between Townships 17 and 18 to the line between Ranges 87 and 88; thence south on said line between Ranges 87 and 88 to the line between Townships 16 and 17; thence east on said line between Townships 16 and 17 to the line between Ranges 83 and 84; thence south on said line between Ranges 83 and 84 to the southwest corner of Sec. 6. ~~thence due east to/~~ Twp. 16, N. R. 83 W./the place of beginning.

DISTRICT NO. 11. ENCAMPMENT.

All that territory embraced within the following boundaries shall be known as Encampment Election District No. 11.

Beginning at the southeast corner of Twp. 15. N. R. 83 W.; thence North to the southeast corner of Sec. 1. Twp. 16. N. R. 83 W.; thence west to the southwest corner of Sec. 6, Twp. 16. N. R. 83 W.; thence north to the northeast corner of Township 16, N. R. 84 W.; thence west to the line between Ranges 85 and 86; thence south on said line between Ranges 85 and 86 to the line between townships 14 and 15; thence due east to the place of beginning.

DISTRICT NO. 12. BENNETT.

All that territory embraced within Townships 15, 16 and 17 in Ranges 81, 80 and 82 W. shall be known as Bennett Election District No. 12.

DISTRICT NO. 13. COLLINS.

All that territory embraced within the following boundaries shall be known as Collins Election District. No. 13.

Beginning on the boundary line between Carbon and Albany Counties and on the boundary line of the State of Colorado and Wyoming; thence north on the eastern boundary line of Carbon County to the line between Townships 14 and 15; thence west on said line between Townships 14 and 15 to the line between Ranges 86 and 87; thence south on said line between Ranges 86 and 87 to the line between Secs. 19 and 30 Twp. 14 N. R. 86 W.; thence east on said line between sections 19 and 20 to the corner of Sections 19, 20, 29

and 30 Twp. 14. N. R. 86 W.; thence south on said line between Sections 29, 30, 31 and 32 Twp. 14. N. R. 86 W. to the township line between townships 13 and 14; thence west on the said township line between townships 13 and 14 to the line between Ranges 85 and 86 W.; thence south on said Range line between Ranges 85 and 86 to the Colorado State Line; thence east along the Colorado State Line to the place of beginning.

DISTRICT NO. 14. SNAKE RIVER.

All that territory embraced within the following boundaries shall be known as Snake River Election District No. 14.

Beginning at a point of intersection of the Colorado State Line and the line between Ranges 85 and 86, thence north on said line between Ranges 85 and 86 to the line between Townships 13 and 14; thence west on said line between townships 13 and 14 to the section line to the section line between sections 31 and 32, Twp. 14. N. R. 86 W.; thence north on said line between sections 29, 30, 31 and 32 Twp. 14. N. R. 86 W., to section corner between sections 19, 20, 29 and 30 Twp. 14. N. R. 86 W.; thence west on said section line between sections 19 and 30 Twp. 14. N. R. 86 W. to the line between Ranges 86 and 87; thence north on said range line, <sup>to line</sup> ~~since 2nd~~ between townships 14 and 15, to the Range line between Ranges 85 and 86, <sup>thence south</sup> to the line between townships 16 and 17; thence west on said line between townships 16 and 17 to the Range line between Ranges 87 and 88; thence south on said line between Ranges 87 and 88 to the line between townships 15 and 16; thence west on said line between townships 15 and 16 to the dividing line between Carbon and Sweetwater Counties; <sup>thence south</sup> to the Colorado State Line; thence along the Colorado State Line to the place of beginning.

DISTRICT NO. 15. SULPHUR.

All that territory embraced within Townships 16, 17, 18 and 19, Ranges 89, 90, 91, 92 and 93 W. in Carbon County, Wyoming, shall be known as Sulphur Election District No. 15.

DISTRICT. NO. 16. WALCOTT.

All that territory embraced within Townships 19, 20, 21, 22, and 23 and 24 Ranges 84 W. shall be known as Walcott Election District No. 16.

Election District No. 1 shall consist of three election precincts.

RAWLINS PRECINCT NO. 1, shall consist of all that portion of the City of Rawlins lying south of Lincoln Highway Street in the City of Rawlins, also all territory outside of corporate limits of said City of Rawlins, lying south of the Union Pacific Railroad Track in said Election District No. 1.

RAWLINS PRECINCT NO. 2, shall consist of all that portion of the City of Rawlins, lying north of Lincoln Highway Street and west of Fifth Street in said City of Rawlins.

RAWLINS PRECINCT NO. 3, shall consist of all that portion of the City of Rawlins, lying north of Lincoln Highway Street and east of Fifth Street in said City of Rawlins, also all that territory outside of the corporate limits of said City of Rawlins, lying north of the Union Pacific Railroad Track in said Election District No. 1.

Election District No. 2 shall consist of two election precincts.

WHISKEY GAP PRECINCT NO. 1, shall consist of all that territory embraced within townships 25, 26, Ranges 87, 88 and 89 W. and Townships 27 and 28, Ranges 88 and 89 W.

FERRIS PRECINCT NO. 2, shall consist of all that territory embraced within Election District No. 2, not included in Whiskey Gap Precinct No. 1.

Election District No. 3 shall consist of one election precinct.

FORT STEELE PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 3.

Election District No. 4, shall consist of five election precincts.

LEO PRECINCT NO. 1 shall consist of all that territory embraced within Townships 24, Ranges 82 and 83, and all of Townships 25, Ranges 82 and 83 and that portion of Range 84 lying east of the North Platte River in Township 25.

SHIRLEY PRECINCT NO. 2, shall consist of all that territory embraced within Townships 26, Range 81 and Townships 27 and 28 in Ranges 81 and 82.

COWDIN PRECINCT NO. 3 shall consist of all that territory embraced within Township 26 Range 82, and all of Township 26 in Range 83 and that part of Twp. 26, Range 84 W. lying east of the North Platte River.

PEDRO PRECINCT NO. 4 shall consist of all that territory embraced in Townships 27 and 28 in Ranges 83 and 84, except that part of Township 27 Range 84 lying west of the North Platte River.

DIFFICULTY PRECINCT NO. 5 shall consist of all that territory embraced within Townships 24 and 25 N. R. 80 and 81 W. of the 6th. P. M.

Election District No. 5 shall consist of one election precinct.

MEDICINE BOW PRECINCT NO. 1 shall consist of all that territory embraced within Election District No. 5.

Election District No. 6 shall consist of two election precincts.

HANNA PRECINCT NO. 1 shall consist of all that territory embraced within said Election District No. 6, except Sections 15, 16, 21 and 22 in Twp. 22, N. R. 81 W.

ELMO PRECINCT NO. 2 shall consist of all that territory embraced within Sections 15, 16, 21 and 22 in Twp. 22, N. R. 81 W. of the 6th. P. M.

Election District No. 7 shall consist of one election precinct.

ELK MOUNTAIN PRECINCT NO. 1 shall consist of all that territory embraced within Election District No. 7.

Election District No. 8 shall consist of three election precincts.

ROCKDALE PRECINCT NO. 1 shall consist of all that territory embraced within Townships 19, Ranges 77, 78 and 79 W. in said Election District No. 8.

MORGAN PRECINCT NO. 2 shall consist of all that territory embraced within Townships 17 and 18 Ranges 77 and 78 and 79 in said Election District No. 8.

WIDDFIELD PRECINCT NO. 3 shall consist of all that territory embraced within Townships 18 and 19 Range 80 and Township 18 N. R. 81 W. in said Election District No. 8.

Election District No. 9 shall consist of one election precinct.

GREEN PRECINCT NO. 1 shall consist of all that territory embraced within Election District No. 9.

Election District No. 10 shall consist of one election precinct.

SARATOGA PRECINCT NO. 1 shall consist of all that territory embraced within Election District No. 10.

Election District No. 11 shall consist of three election precincts.

COW CREEK PRECINCT NO. 1 shall consist of all that territory embraced within said

Election District No. 11, divided by Cowie Creek and Calf Creek, except that divided by Calf Creek. ~~Riverside Precinct No. 3.~~

SPRING CREEK PRECINCT NO. 2, shall consist of all that territory embraced in said Election District No. 11, divided by Spring Creek and Calf Creek, except that part embraced within Riverside Precinct No. 3.

RIVERSIDE PRECINCT NO. 3, shall consist of all that territory embraced in Twp. 15, N. R. 83 W. and also the Town of Riverside in Sec. 1, Twp. 14. N. R. 84 W. except Sections 5, 6 and 7 in Twp. 15. N. R. 83 W.

Election District No. 12 shall consist of Three Election Precincts.

BENNETT PRECINCT NO. 1 shall consist of all that territory embraced within said election district No 12, within the West Half of Twp. 15. N. R. 82 W. and all of Townships 16 and 17, Ranges 80, 81 and 82, except that land embraced within School District No. 23.

FRENCH PRECINCT NO. 2, shall consist of all that territory embraced within the East Half of Twp. 15, N. R. 82 W. and all of Twp. 15, in Ranges 80 and 81 W. in said Election District No. 12.

WIANT PRECINCT NO. 3, shall consist of all that territory embraced within School District Co. 23, of Carbon County, Wyoming.

Election District No. 13 shall consist of Three Election Precincts.

COLLINS PRECINCT NO. 1, shall consist of all that territory embraced within Townships 12, 13 and 14 in Ranges 83 and 82 W.

ENCAMPMENT PRECINCT NO. 2, shall consist of all that territory embraced within that part of Twp. 14, N. R. 86 W. embodied in said Election District No. 13, and all of Townships 12, 13 and 14, Range 85 W. and Townships 13 and 14 in Range 84 W. except that part embraced within the town of Riverside and precinct, also all that territory embraced within Twp. 12 N. R. 84 W. in said Election District No. 13.

BIG CREEK PRECINCT NO. 3, shall consist of all that territory embraced within all that portion of Election District No. 13, in Twps. 12, 13 and 14, Ranges 80 and 81 W.

Election District No. 14, shall consist of Four Election Precincts.

SAVERY PRECINCT NO. 1, shall consist of all that territory embraced within said Election District No. 14, in Twps. 12, 13, 14, 15 and 16, Ranges 86, 87, 88 and 89 W.

DIXON PRECINCT NO. 2, shall consist of all that portion of Election District No. 14, embraced within Townships 12, 13, 14 and 15, Range 90 W.

BAGGS PRECINCT NO. 3, shall consist of all that portion of Election District No. 14, embraced within Townships 12, 13, 14 and 15, N. R. 91 and 92 W.

SAND CREEK PRECINCT NO. 4, shall consist of all that territory embraced within Election District No. 14, in Townships 12, 13, 14 and 15 N. R. 93 W.

Election District No. 15, shall consist of Two Election Precincts.

SULPHUR PRECINCT NO. 1, shall consist of all that portion of Election District No. 15, embraced within Townships 16, 17, 18 and 19, Ranges 89, 90 and 91 W.

ADAMS PRECINCT NO. 2, shall consist of all that portion of Election District No. 15, embraced within Townships 16, 17, 18 and 19, Ranges 92 and 93 W.

Election District No. 16, shall consist of One Election Precinct.

WALCOTT PRECINCT NO. 1, shall consist of all that territory embraced within said Election District No. 16.
