Mr. James Blackhall, Forest Supervisor of the Hayden National Forest, appeared before the Board relative to the Forest Road from Encampment Wyo. to Slater, Colo., stating that Mr. Whittaker, District Engineer, office Public Roads and Rural Engineering Department, of Denver Colo. and also Mr. Palin, Highway Engineer, had been over the proposed road and the two Engineers thought very highly of the project.

No action had been taken as to the building of this proposed road owing to the fact that the County Road Funds were limited and no available monies to start new work of such a character at this time.

Mr. Whittaker suggested that it would be a good plan for County Commissioners to set aside their half of the estimated cost of the survey as soon as the fund became available so that the survey could be made early in the season of 1919. He also suggested that if it suited the Board, the road could be built as a co-operative project thereby allowing the Forest Service to build their part and the County their part and in so doing the County might use Convict Labor.

Mr. Whittaker also stated that in his opinion the Government might not undertake such work until the war was over on account of the scarcity of labor but the County might possibly be able to begin their work sooner.

The Board after due consideration thought favorable of the proposition but deemed it advisable to take no action at this time.

There being no further business coming before the Board it was moved by Commissioner Rasmussen and seconded by Commissioner Winsor that the meeting adjourn to meet again in regular session on September 3rd. 1918. Motion Carried.
