TO. THE HON. BOARD OF COUNTY COMMISSIONERS of the County of Carbon,

Rawlins, Wyoming.

Gentlemen:

On behalf of the Union Pacific Railroad Company, the Union Pacific Coal Company, and numerous residents of Hanna and vicinity, taxpayers and electors of Carbon County, Wyoming, we desire to file this protest against the issuance of a liquor license to one GUST FAGERHOLM to sell liquor in the Town of Elmo, near Hanna, in said County, for the reason:

That the sale and use of intoxicants in said town of Elmo, which town is a coal mining camp, and approximately within three miles of Hanna, another coal mining camp, necessarily curtails the output of coal from said camps. Men will lay off and visit resorts where liquor is for sale. Coal being an invaluable necessity to the Nation and our Allies in the World's War, every pound capable of production should be extracted and sent to market. Depriving these coal camps of their right to full production is an insidious method of crippling our Government in its win the war policy.

For this reason we ask that no license issue to anyone to sell any liquor or other intoxicant, at or near any coal camp in Carbon County during the period of the war.
