It was regularly moved by Commissioner Rasmussen and seconded by Commissioner Mc Kay, and unanimously carried by the Board, that the contract for the building and construction of a bridge across Snake River at or near the Dolan Ranch in Carbon County according to plans and specifications filed with the Board, be and the same, is awarded to the Colorado Bridge and Construction Co, pursuant to their bid therefore in the sum of Nine Thousand Eight Hundred and Fifty Dollars, the same being the lowest bid offered or received by the Board.

This contract being subject to the rules and regulations of the United States Government and the State of Wyoming pertaining to the construction of said bridge and the furnishing of materials therefor as by law provided.

Subject to the above conditions, as to the construction of said bridge, the Chairman of the Board being authorized and directed to enter into a contract with said Colorado Bridge and Construction Co. according to the terms and specifications therefor on file.
