R-E-S-O-L-U-T-I-O-N.

WHEREAS, regular application has been made to the State Highway Department for the improvement of the Baggs-Wamsutter Road, and

WHEREAS THE SUM of \$2500.00 has been regular appropriated for said improvement,  
and

WHEREAS there is now remaining in the Baggs-Wamsutter Road Fund the sum of \$2500.00, as aforesaid.

BE IT RESOLVED that the further sum of \$2500.00 be appropriated from the road and bridge fund to pay one-half the estimated cost of construction of said road as shown on Federal Aid Project Statement, and in case the cost of construction exceeds the estimated amount due to increased costs of materials and labor or for other contingencies, we pledge ourselves and the County to make available additional amounts up to \$2500.00 to pay the costs above the estimated cost of construction necessary to complete the improvement as shown on the plans, and

BE IT FURTHER RESOLVED that the above amount be set aside in the special fund known as the Baggs-Wamsutter Road Fund, payments to be made from such fund upon vouchers presented by the State Highway Department.
