

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, APRIL, 1st. 1919.

Board met at 10 o'clock A. M. this 1st day of April A. D. 1919, in regular session as is by law required. Roll call showing present, Commissioners R. T. Wood, A. W. Rasmussen, Wm. A. Mc Kay, Chairman and R. A. Magor, Clerk.

Proceedings were had as follows, to-wit:-

The Minutes of the previous session were read and approved.

Mr. C. E. Adams, Jr. Union Pacific Right of Way Agent appeared before the board and presented a Right of Way Lease for County Roads, wherever the County road ~~touch~~ touches the right of way of the Union Pacific Railroad Company in Carbon County, Wyo n . After careful examination, it was moved by Commissioner Rasmussen and seconded by Commissioner Wood that the above Right of Way Lease be accepted. Motion Carried.

Messers James Blackhall, F. H. Healey, G. W. Sisson, H. A. Hunter, and Geo. C. Austin appeared before the Board and presented several petitions signed by a number of residents of Carbon County, petitioning the Board to appropriate the sum of ~~the~~ \$1300.00, as one-fourth the cost of the survey of the Encampment-Slater Road.

After due consideration, it was moved by Commissioner Rasmussen and seconded b by Commissioner Mc Kay and unanimously carried by the Board that the following resolution be adopted , to-wit:-

R-E-S-O-L-U-T-I-O-N

WHEREAS, It satisfactorily appearing to the Board of County Commissioners of Carbon County, Wyoming, that the United States Government, the State Highway Department of the State of Wyoming, are desirous of co-operating with the County of Carbon, State of Wyoming, in the official survey of what is locally known as the Encampment-Slater Road situated between Encampment, Wyoming, and Slater, Colo. a distance of approximately 41.5 miles, it Further being made to appear to said Board that the estimated cost of the surveys of said road will be \$5200.00 and it further appearing to said Board that the said United States Government will pay fifty (50%) per cent of the estimated cost of said survey and the State Highway Department of the State of Wyoming will pay twenty-five (25%) per cent of the estimated cost of said survey, provided the said County of Carbon will pay twenty-five (25%) per cent of the estimated cost of said survey.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners of Carbon County, Wyoming, acting by its duly qualified officers, that the sum of \$1300.00, or so much thereof as may be necessary, being twenty-five (25%) per cent of the estimated cost of said survey of the said Encampment-Slater Road, be and the same is hereby appropriated from the Road & Bridge Fund of said County, said appropriation of \$1300.00 to be deposited to the credit of the Treasurer of the United States of America to be used and paid out by the proper authorities subject to co-operative agreement. Said sum to be deposited in the Denver National Bank of Denver Colo, the same being a United States Depository.

BE IT FURTHER RESOLVED, That the County Clerk is hereby authorized and directed upon the issuance of a County Warrant of the said sum as aforesaid to forthwith send said warrant for deposit to the Denver National Bank of Denver, Colo. to be used subject to the above resolution.
