ROAD.

Pursuant to the published Notice to establish a County Road in Carbon County, Wyoming, known as the Old Grade between Allen Junction and Old Dana, having been published for six consecutive weeks, as by law provided, the first publication having been made on the 27th day of March A. D. 1919 and the last publication having been made on the 1st day of May A. D. 1919, requiring all claims for damages by reason of said proposed road to be filed with the County Clerk of Carbon County, Wyoming, on or before 12 o'clock Noon on the 7th day of May A. D. 1919, the said day and hour having on this day expired, the following claims for damages by reason of said proposed road being filed with the County Clerk, to-wit:-

Pursuant to the Statute in such case made and provided, all matters concerning the said proposed road being continued by the Board at their next meeting thereof on the 4th day of June A. D. 1919, at which time the Board shall appoint three (3) suitable and disinterested electors of Carbon County, Wyoming, as appraisers to view the ground in question and will on said day, to be fixed by the Board, require said appraisers to report their doings, as by law provided.
