

Board met at 10 o'clock A. M. this 8th day of May A. D. 1919, pursuant to adjournment of May, 7th 1919, Roll call showing present, Commissioners A. W. Rasmussen, R. T. Wood, Wm. A. Mc Kay, Chairman and E. A. Magor, Clerk.

Proceedings were had as follows, to-wit:-

-R-E-S-O-L-U-T-I-O-N-

WHEREAS, heretofore, to-wit:- on the 7th day of May, 1919, the County of Carbon, State of Wyoming, has entered into a contract with the State Highway Commission of the State of Wyoming, to contribute to the cost of the survey of that certain Public Road and Highway, known and designated as Encampment-Slater Road and described as follows, to-wit: Encampment, Wyoming and point on Wyoming-Colorado State Line near Slater, Colorado, a distance of 41.7 miles, the sum of \$1300.00 providing said Commission contribute to the said costs of survey the sum of \$1300.00 and the Federal Government the sum of \$2600.00, the same being the balance of the cost of survey of said road or highway (the gross cost of construction being estimated at \$5200.00.)

AND, WHEREAS, and as a condition precedent to entering into a contract with the said County of Carbon to defray any part of the cost of constructing the said road or highway, the said State Highway Commission requires the said County of Carbon to deposit with the State Treasurer, to the credit of the State Highway Commission, the sum of \$1300.00.

AND, WHEREAS, there is to the credit of the road and bridge fund of the County of Carbon and in the hands of the County Treasurer of the said County of Carbon the sum of \$1300.00.

NOW, THEREFORE, Be it Resolved, that the Clerk of the County of Carbon be and he hereby is directed to draw the warrant of the County of Carbon in favor of the Treasurer of the State of Wyoming, for the credit of the State Highway Commission, and against the road and bridge fund, of the County of Carbon in the hands of the County Treasurer aforesaid, and deliver the same to the Secretary of said Highway Commission, and

BE IT FURTHER RESOLVED, That the obligations assumed by the said Highway Commission shall not be in force or binding upon said Commission until such time as the money for which such warrant is drawn, shall have been actually paid into the State Treasury of the State of Wyoming for the credit of the State Highway Commission.

It was moved by Commissioner Mc Kay and seconded by Commissioner Wood and the unanimously carried by the board that the above Resolution be adopted.

BE IT RESOLVED, That whereas, Lots 7 and 8 in Block 5 in Hugus & Chatterton's First Addition to the Town of Saratoga, Carbon County, Wyoming, were sold on June, 30th. 1911, for 1910 taxes, and

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time for redemption has expired whereby title to said property passed into Carbon County, and

WHEREAS, JAMES A. PHILLIPS, has offered to pay to Carbon County to the amount of \$100.00 for said property, which amount will amply re-imburse Carbon County for all taxes incurred to date.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said James A. Phillips for the sum of \$100.00 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said James A. Phillips.

BE IT RESOLVED, That whereas, Lot 8 in Block 14 in the Town of Baggs, Carbon County, Wyoming, was sold on June. 30th. 1916, for 1915 taxes, and

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time for redemption has expired whereby title to said property passed into Carbon County, and

WHEREAS, S. PARK has offered to pay to Carbon County to the amount of \$6.00, which amount will amply re-imburse Carbon County for all taxes, interest, penalties and costs incurred to date.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said S. Park for the sum of \$6.00 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said S. Park.

The application of the Illinois Pipe Line Company for permission to lay one or more lines of pipe in certain highways in said County and after considering the application of said Company, the following resolution was moved by Commissioner Rasmussen and seconded by Commissioner Wood and duly passed, all voting "aye".

BE IT RESOLVED, By the Board of County Commissioners of Carbon County, State of Wyoming, that,

Section 1, To the extent that consent may be granted by said owners of the lands crossed by the said pipe line, consent is hereby granted by the Board of County Commissioners of Carbon County, State of Wyoming, to the Illinois Pipe Line Company, a Corporation organized and existing under the laws of the State of Ohio, authorized to

do business in the State of Wyoming, and its successors and assigns, to pay, maintain, and operate one or more lines of pipe for the transportation of oil along, through and across the several highways of said County that may be traversed, interseded or crossed by the following route: By a line running from a point on the line between Sweetwater and Carbon Counties, Wyoming, located in Section Nineteen (19) Twp. Twenty-six (26) N. of R. Eighty-nine (89) West, running thence in a south eastwardly direction along the pipe line to a point on the Union Pacific Railroad Company in Section 21, Twp. 21, N. R. 85 W. with permission to cross such highways as may be necessary with branch lines to be constructed to the above main line.

Section 2. The above consent is granted upon the following ^{expressed/}conditions.
That all pipe lines laid under this grant shall be buried in the ground not less than eighteen inches beneath the surfact of the same.

As said lines or any portion thereof are constructed along or across any of the highways, the roadway or place where the same is constructed shall be at once restored to as good condition as the same was in immediately preceding the commencing of such construction and for the purpose for which such place or surface was then being used.

Aaid lines shall be so constructed and maintained as not to interfere with or impair the use of said highways and ditches, drains and culverts in connection there- and with for travel by the public or for drainage/~~xx~~ sewerage.

In case the said Board of County Commissioners or thier successors in office shall at any time or from time to time determine to improve in any manner or alter or change the grade, route or materials of said roads or ditches, sewers, drains or culverts and the same shall involve the changing of said pipe lines in any manner, then such changes shall be made in such pipe lines as may be necessary as said Board of County Commissioners or their successors shall direct by the said Company at once, and at its expense.

This resolution and all its terms and conditions shall be and are hereby made binding and obligatory on the successors of said Board of County Commissioners or other officer or officers that may succeed in law to the charge of said public highways or any part thereof, and on the successors and assigns of said Company and all persons or corporations holding by, through or under it.

Section 3. This resolution shall be in force and affect from the date thereof.
