HATCH BROTHERS vs BLACK.

In case from Uinta County, Wyoming, in April, 1917, In a case in which homesteaders had closed a road that had been travelled a number of years by the Public. The Supreme Court of the State of Wyoming held that that the road having been ~~xxx~~ traveled by the public for a number of years, created an easement for the purpose of a highway, even in the absence of any action by the County Commissioners and that the entry-man takes the land subject to the easement or right of way for a highway.

The effect of this decision of our Supreme Court is that it becomes a public highway just as much as though it had been formally established by the Public Authorities.

On motion by Commissioner Rasmussen and seconded by Commissioner Wood, it was ordered that all established roads in the County should not be closed, except with the consent of the Board of County Commissioners of Carbon County, Wyoming. Motion carried.

The petition of Mrs. Recka Foster of Rawlins, Wyoming, asking for Widow's County aid was presented to the Board. Said petition was referred to Mr. A. W. Rasmussen for investigation. he to report on same at the next regular meeting of the Board.

The petition of Mrs. Mary Ellen Favelli of Hanna, Wyoming, asking for Widow's County aid was presented to the Board. Said petition was referred to Mr. S. D. Briggs for investigation, he to report on same at the next regular meeting of the Board.
