Board met at 2 o'clock P. M. this 7th day of August A. D. 1919, pursuant to adjournment of morning session, Roll call showing all members present.

Proceedings were had as follows, to-wit:-

ASSIGNMENT OF TITLE.

At a Tax Sale of delinquent taxes held on June, 27th. 1919, Lots 23 and 24 in Block 25, in the Town of Grand Encampment, Carbon County, Wyoming, was sold for the 1918 taxes to Carbon County, Wyoming. A bid was received from Mr. M. K. Opperman for the assignment of the County's title to the above property, and the check enclosed for \$6.56, being sufficient to pay all taxes, interest, costs, and penalties incurred to date, it was moved by Commissioner Rasmussen and seconded by Commissioner Wood that the offer of Mr. M. K. Opperman be accepted and assignment made. Motion carried.

STOCK INSPECTOR.

A letter was received from the Board of Live Stock Commissioners of the State of Wyoming, asking that the Board appoint a Stock inspector for Carbon County, Wyoming.

The application of Mr. L. B. Magor, as stock inspector, was presented to the Board, he being the only applicant.

It was moved by Commissioner Rasmussen and seconded by Commissioner Wood that L. B. Magor, be and is hereby appointed Stock Inspector for Carbon County, Wyoming upon his filing bond as provided by law.

Roll call of vote: Commissioners Rasmussen, Wood and Mc Kay all voting aye.
NORTH PARK ROAD. 

A petition being filed with the Board asking to have the road running from Tie Siding through Encampment and Saratoga to meet the Lincoln Highway at Walcott, Carbon County, Wyoming, be made and established as a State Highway.

Said petition was duly considered by the Board and it was regularly moved and seconded that a resolution be adopted by the Board and directed to the State Highway Commission of Wyoming requesting them to take proper action.

The following resolution was unanimously adopted by the Board.

BE IT RESOLVED, That the State Highway Commissioner of the State of Wyoming is hereby petitioned to use its best endeavors to establish as a State Highway, that certain road running from Tie Siding, Wyoming, through Encampment and Saratoga and connecting with the Lincoln Highway at Walcott in Carbon County, Wyoming, and that said road be designated as a State Highway.

BE IT FURTHER RESOLVED that this resolution is based upon a petition being heretofore filed with this Board signed by many tax-payers and electors of Carbon County, Wyoming, residing in Platte Valley and in the vicinity of said proposed road.

BE IT FURTHER RESOLVED that the Board of County Commissioners of Carbon County, Wyoming, are of the opinion that the designation of said road as a State Highway would be of great benefit to the citizens of this County and that this Board does recommend to the State Highway Commission~~s~~ to use its influence and authority in establishing said road as a State Highway.

There being no further business coming before the Board it was regularly moved and seconded that the meeting adjourn to meet again in regular session on September 2nd, 1919. Motion carried.
