A petition was received protesting against the issuance of a license to Harry Wright ~~for~~ the town of Elmo, Wyoming, as follows:-

To the Honorable Board of County Commissioners of the County of Carbon, State of Wyoming.
Gentlemen:-

On behalf of the UNION PACIFIC RAILROAD COMPANY, the UNION PACIFIC COAL COMPANY, and numerous residents of Hanna and vicinity, taxpayers and electors of Carbon County, Wyoming, we desire to file this protest against the issuance of a liquor license to one HARRY WRIGHT to sell liquor in the Town of Elmo, near Hanna, in said County, for the reason:

That the sale of intoxicants in said town of Elmo, which town is a coal mining camp and approximately within three miles of Hanna, another coal mining camp, necessarily curtails the output of coal from said camps. Men will lay off and visit resort where liquor is for sale. Coal being an invaluable necessity to the Nation and our Allies, every pound capable of production should be extracted and sent to market. Depriving these coal camps of their right to full production is an insidious method of crippling our Government at the present time.

For this reason we ask that no license issue to anyone to sell any liquor or other intoxicant in, at, or near any coal camp in Carbon County.
