PROCLAMATION AND NOTICE, CALLING AN ELECTION OF THE
QUALIFIED ELECTORS OF THE SCHOOL DISTRICTS IN CARBON COUNTY, WYOMING, HEREINAFTER
MENTIONED, TO ESTABLISH A HIGH SCHOOL DISTRICT.

Minutes of meeting.

OCTOBER 3d, 1922.

On this day, being the first day of the regular monthly meeting of the Board of County Commissioners, of Carbon County, Wyoming; a petition was presented to the Board; wherein ever one hundred freeholders and bona fide electors and residents of the School Districts hereinafter mentioned, in Carbon County, Wyoming, (a portion of such freeholders being residents in each of the School districts hereinafter mentioned, did petition the board of County Commissioners; requesting the organization and establishment of a High School District, to be known as "Platte Valley High School, State of Wyoming," in the said County of Carbon; describing boundaries thereof, and describing the lands to be embraced therein by Townships and Ranges, and Fractions of Townships; in said County of Carbon; to be embraced therein, and to include in said High School District as aforesaid; the following School Districts in said County of Carbon, to-wit: School Districts Numbers 9; 18; 8; 10; 26; 30; 35; 23; 22; 17 and 13; all as will more fully appear and as set forth in said petition filed herein, reference thereto made. The said Board at their first meeting following the filing of said petition, and on this, the said 3d day of October, 1922, did fully consider said petition this day presented.

Pursuant to Chapter 155, Compiled Statutes of Wyoming, 1920, upon motion duly made, seconded and unanimously carried by the Board, did authorize and direct that an election be had and held in each of the said School Districts; by the qualified electors residing therein as by law provided; on the 18th day of November, A. D. 1922, at the hour of Two o'clock P. M., of said day, and that said election is hereby called for said time and place in each of said districts at said time and place, and that the Board orders and directs that a notice and proclamation thereof, be published, by giving Twenty days publication thereof, ~~xxxxxxxxxx~~ in the Rawlins Republican, the official paper of Carbon County, Wyoming, that the question of the creation and establishment of such High School District, will be submitted to the qualified electors of the said Territory embraced in such High School district, to-wit: in each of said school districts herein mentioned; on the said 18th day of November, A. D. 1922, at the hour of Two O'clock P. M., the same to be conducted in all respects the same as election of School Trustees; except the Board of County Commissioners shall call such election, pursuant to the said Chapter as aforesaid.

The Notice and Proclamation calling said election being this day signed for and in behalf of the Board by Wm. A. McKay, Chairman, and attest by the County Clerk, and ordered published for said period of twenty days as aforesaid. Said notice and proclamation as published being ordered filed herein.

It was motioned, duly made, seconded and carried by the Board, that the County Clerk, for and in behalf of the Board, shall after the first publication of said Notice and Proclamation, immediately notify in writing each of the trustees in each of the said School districts herein mentioned, of the time and place of the holding of said election; and it shall be the duty of the trustees of each of said school districts to post a copy of said published Notice and proclamation immediately upon the front door of each school house in each of the said respective school districts, of such impending election.

That due return be made by the Judges of such election from each school district of the result of such election as provided by said Chapter.
