REGARDING COUNTY ROAD.

As advertised in the in the September proceedings regarding the proposed County Road, as follows:- Road being a strip of land sixty feet in width and lying 30 feet each side of a line described as follows; Beginning at a point on the center line of the Rocky Mountain Highway, 1164 feet west of the corner common to Sections 23, 24, 25 and 26 in Township 20 N. Range 84 W. 6th P. M., thence east along section lines between Sections 23 and 26, 24 and 25, Township 20 N. Range 84 W., Sections 19 and 30, 20 and 29, 21 and 28, 22 and 27 to the corner common to Sections 22 23, 26 and 27, Township 20 N. Range 83 W. 6th P. M., and there terminating.

All objections thereto or claims for damages by reason thereof to be filed in the office of the County Clerk of said County, in writing, on the 29th day of December, A. D. 1922, or such road would be established without reference to such objections or claims for damages.

There being no objections filed as above stated, said road is hereby established and made a County Highway.

There being no further business to come before the board, it was duly motioned and seconded that said meeting adjourn to meet again on January 2d, A. D. 1923, for the purpose of installing the newly elected and qualified officers and Board.
