Regular Meeting of County Commissioners.

As by law required the Board met this 3rd, day of April, A.D. 1923 at 10 o'clock a.m. for the consideration of such business as should come before it. There were present D. West, chairman, A. Nelson and C. W. Morgan, with D. West presiding.

Road Supervisor, E. W. Hughes appeared before the board and presented to the board the condition of the Rocky Mountain Highway from Rawlins to the Bair Oil Camp. After due consideration it was agreed that as soon as the roads permitted the board would make an inspection tour over that part of the road with the view of making such improvements as were possible under the present conditions.

After an exhaustive discussion the board agreed to do what they could to put the road in a passable condition.

Immediately following the above committee appeared another to urge on the board the necessity of having the Bull's Canyon dam repaired so as to turn the drainage from that waterway into the Hog Back Lake. The proposition was taken under advisement.

COUNTY ROADS. After consultation with County Surveyor Wisda as to the necessity of getting the county roads on record and in view of the fact that there were a number of roads that should be on record it was moved by Andy Nelson and seconded by C.W. Morgan and carried that the county clerk be instructed and required to go over the records of the Commissioners Proceedings for the last twenty years and gather full information of the action of the past Commissioners in acquiring and establishing county roads.
