

The BOARD OF COUNTY COMMISSIONERS met in regular session this fourth day of September with all members present and David West in the chair.

Mr.D.B.Miller, contractor of the three steel bridges to be constructed in the Elk Mountain district, appeared before the board and by way of suggestion explained a new type of abutment now being used in bridge construction and its advantages in any permanent work. After hearing the advantages of the later style as compared with the style called for in the contract, it was regularly moved by C.W.Morgan and seconded by Andy Nelson and carried that the new style be substituted for the one specified in the contract.

After considering the petitions and letters from a number of parties interested in the maintenance of a county road over Brown's Hill from the Savery Creek it was decided that the board would visit that section on the last of September and meet with the residents and decide on a permanent location for a road.

The TAX LEVY was then taken under consideration and disposed of by the following order:
