

ON TUESDAY March 6th, 1923 the Board of County Commissioners met for the consideration of such business as should come before it at this session. All members being present with Mr. David West as chairman.

In anticipation of a petition being presented by the Medicine Bow School District for a re-arrangement of the two districts of Hanna and Medicine Bow there appeared a delegation from the Hanna school district with the principal of that school as spokesman. After hearing the plea from the Hanna district and there being no one to protest their position it was regularly moved, seconded and carried that the idea be postponed indefinitely.

Mr. Hilton, supervisor of the Medicine Bow forest reserve appeared before the board with a request that this county appropriate a sufficient sum of money to build a section of the road lying in Carbon County for the completion of a highway through the Medicine Bow Forest Reserve. After hearing supervisors ^{plea} they took the matter under advisement and after due consideration finally decided that owing to the financial condition of the county at this time they would be unable to co-operate with the Forest Supervisor at present.

Another delegation appeared before the Board asking that, in order that they may receive the full benefit of the federal government's system of financing public road building, they proceed to have all the roads used in the county as county roads surveyed and recorded as such.. The proposition was taken under consideration by the board but no executive action was taken at this session.

The proposition to have the ditch leading into the hogback lake extended up the creek beyond the dam that is now washed out, with a view of getting rid of the maintenance of the dam was also presented to the board by the above delegation. This matter was given over to Mr. Morgan for investigation.

Motion carried for a noon recess.

NOTICE OF CITY ELECTION.

Notice from the City Clerk of the City of Rawlins that their annual city election would be held on the 10th,day of April 1923.

Notice ~~was~~ thereupon was given the Registration Agents of the election districts embracing the City of Rawlins,to appear at the lawfully designated places of registration on the third Tuesday preceding such day of election,to-wit Tuesday the 20th day of March A.D. 1923 and to proceed to register all citizens who appear,,claim the right,and are qualified to register, and ~~was~~ who,by reason of not being registered,would be disqualified from voting at such election,and that such registry agents be required to post notices of the registration of electors in the manner provided by law; and that said registry agent shall meetx for three consecutive days, and then adjourn for one week, and shall meet one day for the purpose of revising,correcting and completing such registry lists and the registration of such qualified electors who have not theretofore registered.

The clerk of said board was instructed to notify the registration agents to meet at the City Hall on Tuesday March 20th, A.D.1923 and to proceed to register as by law required.

There being no further business before the board the meeting adjourned until April 3rd,A.D.1923.
