

Board resumed its session this 7th, day of November at ten o'clock a.m. with all members present.

The following resolution was introduced by C.W. Morgan: "That the offer of the Carbon County Building Association of \$200.00 in full settlement of the judgment lien of Carbon County, State of Wyoming, against the real estate of F.M. Bible in Rawlins, Wyoming be accepted and chairman of board of county commissioners be ordered to release judgment in full upon the court records of Carbon County." Resolution unanimously carried.

By resolution regularly made and carried it was decided to accept the bid of James King of Albany County for one hundred, sixty two and 34/100 Dollars for the mining claims in Gold Hill known as the Acme and Lakeside Placer, Golden Wedge, Leviathan, Wyoming and Banknote, Little Giant, King Solomon Placer and Bridal Veil and Enterprise; and the Lode Claims Nos. 117, 92, 96, 146, 147 and 150.

As compensation for injury to the property of R.L. Tully Jr. by the Rocky Mountain Highway project thorough his land "it was moved by C.W. Morgan, seconded by A. Nelson and duly carried that he be allowed twelve spools of fence wire in full settlement of his claim.

ROAD VIEWER, FOR Rocky Mountain Highway between Saratoga and Encampment. Moved by A. Nelson and seconded by C.W. Morgan that L.E. Vinyon be appointed to view the above mentioned project.

Offer of J.Martinez to place street lamps around the Court House block, by motion duly made and carried was laid over until the next board meeting.

The following bill was taken under consideration: To balance due L.J.Dolan for completion pf bridges at Baggs \$5322.48.

By motion made and carried the clerk was instructed to issue Certificate of indebtedness as follows:

To L.J.Dolan, assigned, partial payment on Baggs bridge. \$5000.00

The balance was necessarily held for ninety days in compliance with the Wyoming Statutes.

The being nothing further before the board at this time it was moved and carried that they adjourn until December 2nd, next at ten o'clock a.m.
