REPORT OF ROAD VIEWER:

The following report of L.E. Vivion, appointed by the board to view and report on the right-of-way for the Rocky Mountain Highway project between Saratoga and Encampment was presented to the board and on motion by David West, seconded by C.W. Morgan and duly carried it was accepted and ordered placed on the records of meeting:

"To the board of County Commissioners of Carbon County, Wyoming:

I, L.E. Vivion, the viewer duly appointed by the board of county commissioners of Carbon County, Wyoming, on November 6th, 1924, to view and investigate the feasibility and practicability of the proposed Rocky Mountain Highway, the route of which is more fully set forth in the petition for the establishment of said highway now on file in the office of the county clerk of Carbon County, Wyoming, herewith submit this as my full and complete Report in reference to the establishment of said road.

On or about November 7, 1924 I went to the route of the proposed Rocky Mountain Highway, in company with one Charles Wilcox and one Ed Sears, residents of the Platte Valley of Carbon County, Wyoming, and, starting at the point of intersection of the present

Saratoga and Encampment road and the proposed Rocky Mountain Highway in section 7, Township 15 North, Range 83 West, I traversed and viewed the site of the proposed road from the said point of intersection to the termination of the proposed route in Section 5, Township 16 North, Range 83 West. I find that said proposed route for said Rocky Mountain Highway is practicable and is a better route than the present road between Saratoga and Encampment for two reasons: First, that the grade percentage is less, and second, that the proposed route is a better winter road for the reason that it would not be covered by drifting snow as much as the present route.

I further recommend the establishment of the proposed route if the same can be accomplished at a reasonable cost, but would not recommend its establishment at too great an expense.

I further find that the sum of \$25.00 per acre would be a very fair and adequate compensation for any damage done to the property owners along the proposed route, which said figure is arrived at by taking into consideration the benefits of the completion and establishment of said road to the adjacent property holders.

Not being familiar with the present plan of construction of the said proposed road, I am in no position to state the probable expense of constructing the same.

I further state that I am a voter and tax-payer of Carbon County, Wyoming, and am absolutely disinterested in the question of the damages to the adjacent property owners.
