

BOARD OF COUNTY COMMISSIONERS met this 4th day of August, all members being present and C.W.Morgan presiding.

Mr.Thurman Arnold and Mr.F.C.Richards of Medicine Bow appeared before the board at this time in regard to a road crossing north of Medicine Bow and after a thorough investigation of the proposition and the submission of the following resolution <sup>and agreement</sup> the same was adopted on motion offered by P.LGooldy, seconded by W.M.Englehart and duly carried:

WHEREAS:

Upon investigation of the petition of Richards Brothers Inc, to for permission to maintain a cattle guard upon the roads from Medicine Bow, Wyoming, to Alcova, Wyoming, from Medicine Bow, Wyoming, to Little Medicine, Wyoming, on Section Thirty-three, Township Twenty-five, Range Seventy-eight and Section Thirty-four, Township, Twenty-six, Range Seventy-eight, where said roads cross the field of said Corporation, the following facts appeared to the board to-wit:

The said cattle guard is of good construction, being made of steel rails, sixteen feet long, so placed that any motor vehicle can cross it without slowing down, and without any unnecessary jar, and at the said of said road a gate, made of steel, and convenient to open has been placed. If the said cattle guard is not constructed it will be necessary to compell the construction of a lane through the field, about seven miles long. This lane will be impassible in the winter time for the reason that the road is not graded, and passes through draws which choke up with snow. If the field is open as it is now the road can be traveled by taking to the ridges and avoiding the drifts, which could not be done in a lane passing through the field. In order to make such a lane possible it would be necessary to grade the road for a distance of seven miles, which expense the County is not in a position to undergo at the present time.

IT IS THEREFORE RESOLVED that the said cattle guard under present conditions and as at present constructed does not constitute an obstruction of said County road, and on the contrary renders the road more passible than is a lane were built. It is further resolved that permission be granted to Richards Brothers Incorporated under the statute giving The Board of County Commissioners supervision and control of all County roads, to maintain said cattle guard as at present constructed until further notice from this Board.

NOW THEREFORE, WE, the boundary board in session duly assembled hereby declare the above mentioned school districts to be amalgamated and known as School District No.9.


