DAMAGE AWARD ON ROCKY MOUNTAIN HIGHWAY BETWEEN SARATOGA AND ENCAMPMENT:

The Commissioners next proceeded to read and consider the report of the appraisers of the proposed Rocky Mountain Highway filed with the county clerk on March 26th, 1925 and thereupon decided to lay out, alter and establish the proposed Rocky Mountain Highway on the hereafter described route:

Beginning at a point which is 926.4 feet S. 42 deg. 38 Min. E., of a point which is 2786.2 feet S. 44 deg. 02 min. E., of a point which is 724 feet S. 0 deg. 42 min. E., of the NW corner of Section 5 T. 16 N., R. 83 W. of the Sixth Principal Meridian, Wyoming.

The point of beginning being the point of a 2 deg. curve to the right, the bearing of the tangent being S. 42 deg. 38 min. E., Thence along said curve through an angle of 16 deg. 28 min., 823.3 ft. Thence S. 26 deg. 10 min. E., paralleling the west right of way line of the Saratoga and Encampment Railroad. 13,682.1 ft. To point of a 15 deg. curve to the right the radius of which is 382 ft. Thence along said curve through an angle of 52 deg. 40 min., 351.1 ft. Leave railroad. Thence S. 26 deg. 30 min. W., 6009.8 feet. To point of a 3 deg. curve to the right the radius of which is 1909.9 ft. Thence along said curve through an angle of 9 deg. 25 min., 313.9 feet. Thence S. 35 deg. 55 min. W., 998 feet. To point of a 5 deg. curve to the left the radius of which is 1145.9 feet. Thence along said curve through an angle of 15 deg. 300 feet. Thence S. 20 deg. 55 min. W., 2888.5 feet. To point of a 5 deg. curve to the left the radius of which is 1145.9 feet. Thence along said curve through an angle of 20 deg. 57 min., 419 ft. Thence S. 0 deg. 02 min. E., 1077.3 ft. Intersect line between sections 29 and 32 T. 16 N., R. 83 W. Whence the southeast corner of said section 29 bears S. 89 deg. 39 min. E., 1325.8 ft. Thence S. 0 deg. 02 min. E., 1196.3 ft. To point of a 4 deg. curve to the right the radius of which is 1432.4 ft. Thence along said curve through an angle of 9 deg. 24 min. W., 235 feet. Thence S. 9 deg. 22 min. W. 3895.1 feet. Intersect line between section 32 T. 16 N., R. 83 W. and Section 5 T. 15 N., R. 83 W. Whence the south $\frac{1}{4}$ corner of said section 32 T. 16 N., R. 83 W. bears N. 89 deg. 07 Min. W. 671.3 ft. Thence S. 9 deg. 22 min. W., 5292.2 ft. Intersect line between sections 5 and 8 T. 15 N.,

R. 83 W. Whence the southeast corner of said section 5 bears S. 89 deg. 24 min, E., 2742.4 ft. Thence S. 9 deg. 22 min. W., 185.9 feet. To point of a 8 deg. curve to the right the radius of which is 716.2 ft. Thence along said curve through an angle of 32 deg. 37 min., 407.7 ft. Thence S. 41 deg. 59 min. W., 1039.6ft. To point of a 3 deg. curve to the right the radius of which is 1909.9 ft. Thence along said curve through an angle of 9 deg. 43 min., 323.9 ft. Thence S. 51 deg. 42 min. W., 1411.7 ft. To point of a 1 deg. curve to the right the radius of which is 5729.7 ft. Thence along said curve through an angle of 2 deg. 32 min., 253.3 ft. Thence S. 54 deg. 14 min. W., 111.6 ft. Intersect line between sections 7 and 8 T. 15 N., R. 83 W. Whence the southwest corner of said section 8 bears S. 0 deg. 11 min. E., 2666.6 ft. Thence S. 54 deg. 14 min W., 1103.2 ft. To point of a 10 deg. curve to the left the radius of which is 573 feet. Thence along said curve through an angle of 30 deg. 57 min., 309.5 ft. Thence S. 23 deg. 17 min. W., 1841.8 ft. Intersect line between sections 7 and 18 T. 15 N. R. 83 W. Whence the south $\frac{1}{4}$ corner of said section 7 bears N. 89 deg. 35 min. W., 830.7 ft. Thence S. 23 deg. 17 min. W., 107.3 ft. end of project which is 107.3 feet S. 23 deg. 17 min. W., of a point which is 830.7 ft. S. 89 deg. 35 min. E. of the South $\frac{1}{4}$ corner of section 7 T. 15 N., R. 83 W.

After duly considering and discussing the damages sustained by the different claimants and protestants on said proposed route, the said board of county commissioners of Carbon County, Wyoming, by motion duly made, seconded and carried allowed the following damages to the said claimants and protestants as follows:

Saratoga Alfalfa Farms and Cattle Co., \$1000.00; Loski D. Peck \$450.00; C.M. Wilcox \$1250.00; Mrs. George Graef \$400.00; Mrs. Mollie F. Day McKee \$1750.00; Ida M. Sowder \$800.00.

It was then duly moved, seconded and carried that the county clerk should notify each of said claimants by registered mail of the amount of damages allowed each of said claimants for the injury to be incurred by the ~~xxxx~~ establishment and construction of the proposed Rocky Mountain Highway through their land; and that said claimants be notified that, any appeal from such final award of said damages must be made within thirty days of said award, to wit: by May 9th, A.D. 1925.

On motion duly made and carried it was decided to recess until April 9th, at ten o'clock a.m.

Board resumed its session this 9th, day of April with all members present.
