SPECIAL MEETING

Board met in special session this 18th day of August, A.D. 1926 at ten A.M. to consider such bids as should come in for the construction of the Snake River Bridge near Dixon. The following bids were opened as below stated:

On the two span bridge of 95 feet each-J. F. Turpin bid \$21,789.40

On the one 190 foot span- - - - - J. F. Turpin bid 22,798.00

On the 295 foot span bridge- - C. G. Sheeley's- - - bid 23,586.00

On the 190 foot single span- - C. H. Sheeley's- - - bid 23,516.50

ROAD

The Monarch Engineering Co., presented a bid on the 190 foot span bridge complete at \$16,895.00.

There being no plans and specifications on file covering the bid of the Monarch Engineering Co., made it impossible to consider their bid at this time.
