COUNTY COMMISSIONERS PROCEEDINGS DECEMBER 29, 1926

Board of County Commissioners met this 29th day of December A. D. 1926 at 10 O'clock A. M. all members being present and C. W. Morgan presiding.

Judge Shattuck representing the Mortgagees of the F. K. Johnson Ranches appeared before the Board at this time offering the taxes and penalties in full for the above named Ranches. The following resolution was thereupon spread upon the rolls of this board:

R E S O L U T I O N

WHEREAS, at a tax sale held on the 11th day of July, A. D. 1924, for want of other bidders, the property hereinafter described, was bid in by the County Treasurer for the County of Carbon, State of Wyoming, for the amount of taxes then due together with interest and penalty to date of sale; and

WHEREAS, no taxes have been paid on the said property since the sale; and

WHEREAS, the taxes for the year 1922 were not paid, and together with interest amount to the sum of Twenty-two hundred Sixteen and 53/100 (\$2216.53) Dollars; and

WHEREAS, the total amount in taxes, penalties and interest now due upon the said property, amount to the sum of Ten Thousand One Hundred Seventy-seven and 32/100 (\$10,177.32) Dollars; and

WHEREAS, The Merchant's Fire Insurance Company, a Colorado Corporation, has offered to pay said sum for a Commissioners' Deed, conveying the said property; and

WHEREAS, the said Board of County Commissioners, now here in open session, has considered the said bid and is of the opinion that it is to the best interest of the County of Carbon, that the said bid should be accepted:

NOW THEREFORE, be it resolved by the Board of County Commissioners of the County of Carbon, and State of Wyoming, that the bid of The Merchant's Fire Insurance Company be, and the same is hereby accepted and upon payment of the said sum, Ten Thousand One Hundred Seventy-seven and 32/100 (\$10,177.32) Dollars to the Treasurer of this county there be executed by the Chairman and Clerk of this Board, a Deed conveying the property hereinafter described to the said The Merchant's Fire Insurance Company.

The property herein referred to is described as follows, to-wit:

- All of Sections Four (4) and Nine (9) and the West Half (W $\frac{1}{2}$) of Section Ten (10) and the Southeast Quarter (SE $\frac{1}{4}$) of Section ten, (10) less Ten (10) Acres; the East Half (E $\frac{1}{2}$) of Section Eight (8) and the Northwest Quarter of Section Fifteen (15) all in Township Seventeen (17), North of Range Eighty-four (84) West of the Sixth Principal Meridian, containing Twenty-two Hundred Thirty (2230) Acres.
- Also Lots Fourteen (14), Seventeen (17), and Eighteen (18), in Block Thirty-five (35), and Lots Fifteen (15), Sixteen (16), Seventeen (17), Eighteen (18), Nineteen (19), Twenty (20) and Twenty-one (21), in Block Twenty (20) of the Saratoga Real Estate and Improvement Company's West addition to the Town of Saratoga, Carbon County, Wyoming.

Done by the Board in open session at Rawlins, Wyoming, this 29th day of December A. D. 1926.
