



' SPECIAL MEETING



Plummer's report covering his inspection of the proposed alterations and relocations on the Saratoga-Ten Mile Road, on motion duly made and carried it was decided to accept the report of the Viewer which was in accordance with field notes of survey made by the County Engineer and filed with the report.
