

COMMISSIONER'S PROCEEDINGS

Board of County Commissioner's met this 7th day of June A. D. 1927, at 10 O'clock A. M. with all members present and I. K. Miller presiding.

The Board immediately went into convention with a delegation of the Platte Valley Country, who again strongly urged a compliance with their former petition that a highway and bridge be constructed connecting the Medicine Bow Forest Reserve with the Rocky Mountain Highway and the S & E Railroad at or near the Day Ranch near the Mouth of Cow Creek.

The Board expressed deep sympathy with the petitioners and the needs of that district promising to do what they could for the consummation of that project.
