WHEREAS, It appears to the Board of County Commissioners that there is reasonable ground for declaring a vacancy to exist in the office of County Physician of Carbon County, Wyoming; now therefore,

BE IT RESOLVED, by said Board of County Commissioners in regular session sitting, at their regular meeting for the month of December, 1927, that said office be, and the same is hereby declared vacated, and

BE IT FURTHER RESOLVED, that Dr. Raymond W. Barber be, and he is hereby



designated and appointed to the office of County Physician of said Carbon County, effective with the execution hereof, and

BE IT FURTHER RESOLVED, that whenever said County Physician is about to absent himself from this County for a period of one week or more, he be required to designate a competent deputy to be approved by said Board, to carry on said office in his absence, and that he be required to inform the chairman or a member of said Board of his proposed absence.
