COUNTY COMMISSIONERS MEETING JANUARY 4th 1927.

The regularly elected members of the Board of County Commissioners for the incoming term met this 4th day of January A. D. 1927 at 10 O'clock A. M. and upon the presentation of their bonds which were duly approved by the Clerk of the Court as by law required, they together with the holdover member went into regular session as the Board of County Commissioners as follows:

I. K. Miller for 4 yr. term, Frank Schilt for 2 yr. term and P. L. Gooldy the hold-over Commissioner.

Immediately upon convening, upon motion by P. L. Gooldy, seconded by Frank Schilt and duly carried Mr. I. K. Miller was elected permanent Chairman of the Board.

Mr. C. A. Brimmer and others waited on the Board at this time and made a strong plea for the appointment of a County Agricultural Agent. After listening to the many reasons furnished the Board thereupon took the appointment under consideration.

At this time a resolution was presented for the approval of the Board for the appropriation of certain amounts of money received from the Forest Reserve Department to be expended in the improvement of roads in and adjacent to the Forest Reserve. This proposition was also taken under consideration.

Acting upon the application for County Physician by motion made and duly carried Dr. E. A. Kell was appointed County Physician for a term of two years.

On motion by Frank Schilt seconded by P. L. Gooldy and regularly carried The Rawlins Republican was designated as the official paper of Carbon County for a term of Two Years.

BOND FOR TREASURER

By motion made and regularly carried the bond of County Treasurer was fixed at \$50,000.00.

POOR & PAUPER

The Cathedral Home of Laramie which has been taking care of two Wiley Children from Elk Mountain was by motion duly made and carried allowed the amount of \$20.00 a month for their care.

Mrs. Mattie Haines was allowed an increase of \$20.00 per month for the care of John Sublet at Elk Mountain.
