## R E S O L U T I O N

WHEREAS, the Federal Bureau of Public Roads has heretofore completed a large portion of a road between the Towns of Encampment and Slater, in the County of Carbon, State of Wyoming, and

WHEREAS, there now remains to be completed of said road a seven mile section extending westward from the said Town of Encampment, to connect up with the present completed portion of said road, and it appearing that the County of Carbon, State of Wyoming, should participate in the completion of said section in order to make more available the road already completed, and

WHEREAS, it appears that the said Federal Bureau of Public Roads now has available for the completion of said unfinished section the sum of \$41,000.00 which sum is to be applied for that purpose in consideration of certain sums to be appropriated for the same purpose by the County of Carbon, State of Wyoming, now, therefore,

BE IT RESOLVED by the Board of County Commissioners of said County, sitting in regular session, that the said Federal Bureau of Public Roads be informed of the desire and willingness of the said Board of County Commissioners to appropriate out of its current Road and Bridge fund such sum in addition to the said sum of \$41,000.00 as shall prove necessary and expedient for the completion of said seven mile section, not exceeding, however,

the sum of \$6000.00, and

BE IT FURTHER RESOLVED that a copy of this resolution be spread upon the minutes of this session of said board, and that a copy thereof be transmitted to the proper representative of the said Bureau of Roads.


