The Board thereupon recessed, to meet on March 2nd, at ten o'clock A.D., 1927.

Resumed its Session this 2nd day of March at ten A.M. with all members present and I. K. Miller in the chair.

Delegation consisting of G. A. Bible, N. R. Greenfield and H. Breitenstein appeared before the Board at this time and conceding their request, it was regularly moved by F. Schilt, seconded by P.L.Gooldy and duly carried as follows:

R E S O L U T I O N

" Whereas, it is the desire of the Board of County Commissioners of Carbon County, Wyoming to cooperate with the State Highway Department and the Forest Service in building and maintaining roads making the Forest Reserves more accessible,

THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Carbon County, Wyoming hereby expresses its willingness to expend all that portion of forest receipts accruing to Carbon County for the year 1927 in improving a road to be established connecting the Medicine Bow Forest Reserve with the Rocky Mountain Highway. Such expenditure to be made during the year 1928."

And also

R E S O L U T I O N

" Whereas it seems desirable to investigate the practicablility of establishing a highway connecting the western entrance to the Medicine Bow National Forest with the Rocky Mountain Highway,

THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Carbon County, Wyoming request the Forest Service and the State Highway Commission to cooperate with this County in determining the feasibility and practicability of establishing such route and making a survey of the same.

BE IT FURTHER RESOLVED, that for the purpose of carrying this resolution in effect there is hereby appropriated out of funds of this County, not otherwise appropriated, the sum of \$500.00 "

Closely following the foregoing delegation appeared another consisting of Messrs. Garretson, Charles Ellis, Richards, Scott, and Heward, requesting assistance on the Medicine Bow-Casper Highway Project.

As the Board were wholly unfamiliar with this route, they agreed to look over the proposition at their earliest opportunity.

On motion by P. L. Gooldy, seconded by Frank Schilt and duly carried, the following resolution was ordered spread on the Minutes:

R E S O L U T I O N

Be it resolved by the Board of County Commissioners of Carbon County, Wyoming, in regular session assembled, at the February, 1927, meeting, that in order to more fully carry into effect the provisions of Sections 2894-2899 inclusive, Wyoming Compiled Statutes, 1920, the County Treasurer of said County be and he is hereby required to make the following statements to wit:

Immediately following each annual tax sale, and not less than five days prior to the time the County Assessor is required by law to make his tax roll and valuation return to the State, the County Treasurer shall make a certified list of all real property bid in by the County at said Tax Sale, and shall transmit said list to the County Assessor, who shall use said list in preparing the separate Tax Roll described in Section 2895 of said Statutes.

The County Treasurer shall, not later than the 10th day of each month furnish to the County Assessor a statement containing a list of all real property redeemed from the County by the owner thereof, or sold by the county to a private purchaser as prescribed by law, during the preceding month.

Be it further resolved that a copy of this resolution be spread upon the minutes of this meeting, and that a copy thereof be furnished to the County Treasurer and County Assessor of Carbon County.
