Burial of Paupers

Casket, outside box, clothes, transport to the cemetery and bury the remains of any adult County Pauper who dies within the city limits of Rawlins, Wyoming for the sum of \$100.00 for each case.

Paupers who die outside the City Limits will be taken care of as above for \$100.00 each plus transportation charge of .25 per mile one way for ambulance service to place of death.

Children up to and including 10 years of age will be buried for \$50.00 each.

This bid to cover a period of two years commencing January 1st 1929.
