

Commissioners Meeting May 7, 1929.

On presentation of lease #CD 9221-B in favor of Carbon County covering portions of the U. P. right of way at various points in Carbon County for highway purposes, by motion duly made and carried the following resolution was adopted:

WHEREAS, the Union Pacific Railroad Company has tendered to the County of Carbon STATE OF WYOMING an agreement granting to the County certain rights for highway purposes in portions of the Railroad Company's right of way in said County and

WHEREAS, it is considered that the best interests of said COUNTY OF CARBON, STATE OF WYOMING will be subserved by the acceptance of said agreement:

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING:

That the terms of the agreement submitted by the Union Pacific Railroad Company be, and the same are hereby, accepted in behalf of the County of Carbon State of Wyoming:

That the Chairman of said Board of County Commissioners of the County of Carbon State of Wyoming is hereby authorized, empowered and directed to execute said agreement in behalf of said County and that it be duly attested by its Clerk.
