Thereupon the board recessed to meet again on the 9th day of April, A. D., 1931 at the hour of 10 o'clock a.m.

Resuming its session on this the 9th day of April, A. D., 1931 at the hour of 10 o'clock a.m., Present: Frank Schilt, Chairman, Commissioners Glenn C. Penland and Dan C. Kinnaman. Also present: Bertha C. Welsh, County Clerk. Absent: none.

Thereupon the following resolution was introduced, duly considered and unanimously adopted, all members of the Board voting on the adoption of the resolution, which is as follows, to-wit:

RESOLUTION.

WHEREAS, at a general election of the qualified votes of the County of Carbon, in the State of Wyoming, duly called and held on the 4th day of November, A. D. 1930, in accordance with law and pursuant to due notice, the qualified voters of said county did, by a vote of 2,044 ballots "For the bond issue" and 1,676 ballots "Against the bond issue" carry in the affirmative, by a majority of 368 ballots, the question of contracting a bonded debt by said county in the sum of Ten Thousand Dollars (\$10,000.00), for the purpose of providing suitable buildings and grounds for conducting the annual county fair:

NOW, THEREFORE, BE IT RESOLVED that the question of issuing bonds in the sum of Ten Thousand Dollars (\$10,000.00), for the purpose of providing suitable buildings and grounds for conducting the annual county fair within and for said county, has been submitted to a vote of the qualified electors of said county, and that a majority of all of the votes cast on said question was for issuing the bonds. Therefore, it is hereby declared that said election resulted in favor of the issue of said bonds.

BE IT FURTHER RESOLVED:

1. That the negotiable coupon bonds in the name of the County of Carbon, and State of Wyoming, be issued in the sum of Ten Thousand Dollars (\$10,000.00), for the purpose of providing suitable buildings and grounds for conducting the annual county fair within and for said county.

2. That the Chairman of said Board be, and he is hereby authorized and empowered

to have printed or lithographed the requisite coupon bonds of said county in the sum of Ten Thousand Dollars (\$10,000.00).

3. That said bonds shall be numbered from one to ten, inclusive, in the denomination of \$1000.00 each, and shall bear date the first day of June, A. D. 1931; shall be payable absolutely on June 1, A. D. 1951; \$4000.00 of said bonds shall be optional for redemption any time after ten years from date and \$1000.00 of said bonds shall be optional for redemption in each of the years 1935 to 1940 inclusive; said bonds shall bear interest at the rate of six per centum per annum, payable semi-annually, on the first day of June and the first day of December in each year. Both the principal of and the interest upon said bonds shall be payable at the office of the County Treasurer of Carbon County, Wyoming at Rawlins, Wyoming.

4. That said bonds shall bear the signature of the Chairman of the Board of County Commissioners, attested by the County Clerk, who shall affix the county seal thereto, and the coupons attached to said bonds shall be signed by the County Treasurer. Each bond so issued shall be registered by the Clerk of the Board of County Commissioners in a public record book to be kept for that purpose, and therein shall be stated the number, date, amount of the bond, time and place of payment, rate of interest, the number of coupons attached, and any other proper description thereof for future identification. The Clerk of the County shall endorse a certificate upon every such bond, that the same is within the lawful debt limit of the county and is issued according to law.

5. That said bonds and the coupons thereto attached shall be in substantially the following form:

COUNTY FAIR GROUNDS BOND.

The County of Carbon, in the State of Wyoming, for value received, hereby acknowledges itself indebted and promises to pay to bearer

ONE THOUSAND DOLLARS,

on the first day of June, A. D. 1935, with interest thereon at the rate of six per centum per annum, payable semi-annually, on the first day of June and the first day of December in each year, both principal and interest being payable at office of the Treasurer of Carbon County, Wyoming at his office in the Courthouse Building in the City of Rawlins, Wyoming upon presentation and surrender of this bond, and the annexed coupons as they severally become due.

This bond is issued by the County of Carbon, in the State of Wyoming, for the purpose of providing suitable buildings and grounds for conducting the annual county fair within and for said county, under and by virtue of and in full conformity with Chapters 95 and 112, Wyoming Compiled Statutes, 1920, and all laws amendatory thereof or supplemental thereto, and by virtue of the authority of the vote of a majority of the qualified electors of said county voting upon the question at a regular election in said county, lawfully called and duly held on the 4th day of November, A. D. 1930.

AND IT IS HEREBY CERTIFIED AND RECITED that all of the laws of the State of Wyoming have been fully complied with by the proper officers concerned in the issue of this bond, and that all acts and things required to be done, and conditions and things required to exist precedent to and in the issue of this bond, to render the same lawful and valid, have

happened, been properly done and performed, and did exist in regular and in due time, form and manner, as required by law, and that the total debt of said county, including this bond, exceeds neither the statutory nor constitutional limitations of the State of Wyoming.

The faith and credit of said County of Carbon are hereby pledged for the punctual payment of the principal of and interest on this bond.

IN TESTIMONY WHEREOF, the Board of County Commissioners of said county has caused this bond to be signed by its Chairman and attested by its Clerk, under the seal of said county, and has likewise caused the interest coupons hereto attached to be signed by the County Treasurer with his engraved facsimile signature, this 1st day of June, A. 6. That said bonds, when ready for delivery as aforesaid, shall be delivered to the County Treasurer of said Carbon County, to be by him delivered to the purchaser of said bonds, and all money arising from the sale of said bonds shall be paid into the treasury of said Carbon County to the credit of said county.

7. The interest due on said bonds for the year 1931 shall be paid out of any fund of the county which is or may be available therefor. For the purpose of reimbursing said fund and meeting the interest accruing on said bonds promptly when and as the same shall

become due, and for the purpose of creating a sinking fund for the ultimate payment of said bonds, there shall be levied by the Board of County Commissioners of the County of Carbon on all the taxable property in said county, in addition to all other taxes, direct annual taxes as follows:

The sum of six hundred dollars (\$600.00) for interest and the sum of \$1000.00 for principal in each of the years 1931 to 1934 inclusive. In the years 1935 to 1940 inclusive the following:

And in each of the years 1941 to 1950 inclusive a sum sufficient or amount to pay interest as it matures on the principal amount of any bonds of this issue outstanding in any of such years and not called for payment.

Said taxes, when collected, shall be applied solely for the payment of said interest and principal of said bonds, respectively, and for no other purpose whatever, until the indebtedness so contracted under this resolution, principal and interest, shall have been fully paid, satisfied and discharged; but nothing herein contained shall be so construed as to prevent said county from applying any other funds that may be in the treasury of the county and available for that purpose, to the payment of interest or principal as the same respectively mature.

in the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$ ) of Section Sixteen (16), Township Twenty-one (21) North, Range Eighty-seven (87) West of the 6th Principal Meridian. As said lands are laid down and platted and of record in the offices of the County Clerk and Ex-Officio Register or Deeds in and for County of Carbon, State of Wyoming, the said lands above described consist of approximately 3.28 acres.

Thereupon the Board recessed to meet again on April 10, 1931 at the hour of 10 o'clock a.m.

Resuming its session this 10th day of April, A. D., 1931 at the hour of 10 o'clock with Commissioner Frank Schilt in the chair, the Board proceeded to open bids for the construction of county fair buildings in accordance with published notice to contractors and tabulation showed the following bids submitted:

The bids having been considered, contract was awarded to Frank T. Knapp as the lowest and best bidder by motion duly made seconded and carried and contract was then and there executed subject to the filing of surety bond.

#### COUNTY POOR FARM

Consideration was at this time given to the location of the county poor farm and motion made by Commissioner Kinnaman that the permanent location of the poor farm be moved to the old hospital grounds owned by the county in the city of Rawlins and that plans and specifications be prepared for the reconstruction of the old hospital building for that purpose, said plans and specifications to be considered by the board at their next regular meeting May 5th next. Motion seconded by Commissioner Schilt and upon calling for a vote upon said motion, vote was recorded as follows: Commissioner Kinnaman voting "yea" Commissioner Penland voting "nay" and Commissioner Schilt voting "yea" and the motion declared carried.

There being no further business to come before the Board, the meeting was adjourned.
