Following a motion duly made and carried the clerk was requested to prepare a Commissioners Deed in favor of John-Quincy on the following described property

Union Pacific, Carbon Co Agreement

The following resolution of acceptance was moved, seconded and carried

WHEREAS, by lease dated August 3, 1921, as amended by an agreement dated December 8, 1927, the Union Pacific Railroad Company leased to the County of Carbon, State of Wyoming, for a term of 50 years beginning May 1, 1921, certain land in Carbon County, Wyoming, to be used for highway purposes; and

WHEREAS, the Union Pacific Railroad Company has tendered to the County of Carbon, State of Wyoming an agreement, supplemental to said lease dated August 3, 1921, as amended by said supplemental agreement dated December 8, 1927, for the purpose of further amending said lease, as supplemented, by eliminating from the operation of said lease certain land included thereunder and including under the operation of said lease in lieu of the eliminated portions certain additional land of the Railroad Company; said supplemental agreement being identified as Union Pacific Railroad Company's Contract Department No. 3867-G; and

WHEREAS, the Board of County Commissioners of said County has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of the said County of Carbon, State of Wyoming, will be subserved by an acceptance of said agreement;

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING:

That the terms of the agreement submitted by the Union Pacific Railroad Company as aforesaid be, and the same are hereby, accepted in behalf of the County of Carbon, State of Wyoming;

That the Chairman of said Board of County Commissioners of said County of Carbon is hereby authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk of said County is hereby authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.

Motion made by Penland, seconded by Kinnaman, carried, that in as much as an emergency exists at the location known as Muddy Creek at Dad and that the bridge is in a deplorable

unsafe condition it is necessary to erect a new structure and that there is not ample time to advertise for bids and that a bridge be constructed at once.
