On motion duly made and carried the following resolution was ordered:

RESOLUTION

WHEREAS the State Highway Superintendent has submitted in writing to the Board of County Commissioners of Carbon County a proposal whereby the State Highway Commission agrees to make a location survey of the Highway route from Riverside to the Wyoming-Colorado line in consideration of Carbon County agreeing to obtain the right of way on the route surveyed, and agreeing further to expend the sum of \$6000.00 per year for each of the years 1930 and 1931, and,

WHEREAS it appears to be necessary for the public use and convenience that the final route for this highway be selected and that immediate improvement thereof be commenced with a view to having this highway designated for Federal Aid as early as possible, now, therefore,

BE IT RESOLVED that in consideration of a location survey being made on said route by the State Highway Commission, the Board of County Commissioners of Carbon County will procure the right of way with reasonable expedition on the route selected and designated by the Survey, and will expend for the improvement of the route selected the sum of \$6000.00 in each of the years 1931 and 1932.

The foregoing resolution was introduced by Commissioner Frank Schilt, who moved its adoption.

The motion being thereupon put, was carried unanimously.

TAX DEED


