Commissioners Deed

Concordant with the George Washington Memorial Park plan and following a request from the George Washington Memorial Park Committee of Saratoga, a motion was made by Kinnamen seconded by Penland, carried that the following lots now owned by the County, within the town of Saratoga, for one dollar and other considerations be deeded to the town of Saratoga for park purposes.

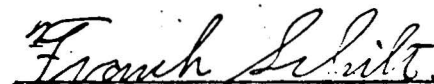
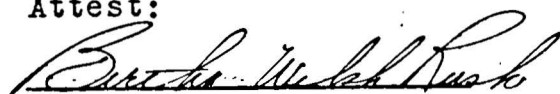
